**SUBJECT: ADMINISTRATIVE APPROVAL FOR THE WORK "FEASIBILITY STUDY, DESIGN & REHABILITATION OF C&W ROADS IN KHYBER PAKHTUNKHWA" SI: IMPROVEMENT/REHABILITATION OF EXISTING ROAD IN U/C NORTH, U/C SHAH MAQSOOD, U/C SARAI SALAH & U/C PANDAK DISTRICT HARIPUR ADP NO.1170/160622 (2016-17)**

In exercise of the powers delegated vide Part-I Serial No.6 Schedule of the Delegation of Powers under the Financial Rules and Powers of Re-appropriation Rules, 2001, the Khyber Pakhtunkhwa Provincial Government is pleased to accord the Administrative Approval for the implementation of the scheme under ADP No. 1170/160622 (2016-17) "Feasibility Study, Design & Rehabilitation of C&W roads in Khyber Pakhtunkhwa" SI: Improvement/rehabilitation of existing road in U/C North, U/C Shah Maqsood, U/C Sarai Salah & U/C Pandak District Haripur" for period of 12 months from 2016-17 to 2017-18) at a total cost of Rs.33,040 million (Rupees Thirty three million & forty thousand only) as per detail given below:

1. The scheme was approved by the DDWP in its meeting held on 03.03.2017. Minutes circulated by C&W Department No. SOR/3-4/G-MTG/W&S/2010 dated 08.03.2017.
2. The expenditure involved will be met out from the Sanctioned budget under the function cum-object classification 04-Economic Affairs-045-Construction & Transport-0452-Road Transport-045202-Highways Road & Bridges (NC 12064) under Grant 56 during current financial year (2016-17).
3. The Administrative Approval does not constitute any sanction to design/ rates/prices provided in the rough cost estimate/escalation. The financial responsibility of the rates & suitability of design rests with the authority competent to accord Technical sanction to the cost estimate.
4. The sanctioning authority shall allow appropriate rates after observing all codal formalities/standing instructions regarding schedule of rates and financial regularity. The work shall be taken in hand after release of funds and proper technical sanction of the cost estimate.
5. As per decision of the Competent Authority dated 22-09-2015 that Road should not have less than 18 feet width except in built-up area or in the area where R.O.W is restricted and require acquisition of land.
