- The interested bidders must deposit cash or submit a Call Deposit of Rs. 5,000/- (non-refundable) in the name of Managing Director PKHA as registration fee and earnest money (refundable) on or before 05:00 PM of <u>MONDAY</u>, 03/06/2024.
- 3) The bidder shall provide their complete address/telephone number/NTN along with a copy of National Identity Card at the time of registration.
- 4) The successful bidder shall have to deposit 25% of the offered amount on the spot, while the balance amount shall be paid within three days of the acceptance of the auction, failing which earnest money shall stand forfeited in favor of the Govt.
- 5) All Government taxes applicable on the bid amount shall be charged as per rules.
- 6) In case of auction date is declared as public holiday by the Government the next working day shall be deemed to be the date for bidding at the same time/place.
- Open auction, in-camera under video recording will be carried out on <u>04-06-2024</u> from <u>1100 hrs</u> to <u>1300 hrs</u> in the committee room of PKHA HQ at Peshawar near KP Bar Council, Attached Departments Complex, Gate#5, Khyber Road, Peshawar.
- 8) Security will be refunded after 15 days of completion of the work.
- 9) The Successful bidders shall obtain NOC / clearance certificate from Finance Section of PKHA for payment of all admissible taxes including stamp duty, service charges, sale tax and any other taxes at prevailing rate before shifting the material from the sites. It is worth mentioning that the amount of taxes will be paid by the successful bidder in addition to the offered bid.
