Applications for shortlisting of consultants in PKHA are invited from those interested Engineering Consultants having vast experience in Feasibility Study / detailed Engineering Design and Construction Supervision to undertake PKHA Roads / Bridges works for the year (2017-18). Consultants already Shortlisted in this Authority through Notifications No. 2-PKHA/46655 dated 07/11/2016 and 2-PKHA/46656 dated 07/11/2016 for the year 2016-17 need not to apply as their shortlisting in PKHA will stand valid for the year (2017-18).

The broader scope of works for Consultants / Firms includes but not limited to.

1. FOR FEASIBILITY STUDY & DESIGN:

- i. Feasibility Study, Project formulation, detailed surveying including topographic, Environmental Impact Assessment etc including preparation of Tender drawings / Construction Drawings.
- ii. Preparation of PC-I, BOQs, Tender documents and evaluation of contractor bids.
- iii. Indemnification of the client to the effect that the consultant shall, entirely, be responsible for design and product qualitatively and quantitatively including responding / defending observations, inspection reports, litigation etc at different fora as and when needed.

2. FOR CONSTRUCTION SUPERVISION:


- i. Construction / detailed supervision including quality / quantity assurance.
- ii. Measurement of works, and verification / approval of variation order and certification of IPCs.
- iii. Collection and deliverance of the cheques to the contractors with obligatory role and financial responsibility.
- iv. Indemnification of the client to the effect that the consultant shall, entirely, be responsible for the work and product qualitatively and quantitatively including responding / defending observations, inspection reports, litigation etc at different fora as and when needed.

The consultants must be registered with PEC in the relevant field having valid license up to 31.12.2017. The applications shall also contain the following information.

- (1). Full address of the firm including land line / Fax, cells, E-mail and any other contacts.
- (2). General and overall experience of the firm (s).
- (3). Experience of working in similar nature and general of works in-hand / completed during last 10-years supported by work orders and completion certificates of Executing agencies concerned.
- (4). Financial soundness including bank statement and audit report by an external auditor for the latest 3-years.
- (5). Nature, cost, per month inputs, employer, location and disciplines of the works undertaken.
- (6). Summary of permanent professional employees, resource persons, including income Tax return of staff.
- (7). National Tax Number (NTN) with Tax return submission certificate of the latest / preceding years.
- (8). Copy of Registration with Khyber Pakhtunkhwa Revenue Authority.
- (9). Affidavit to the effect that the firm is not involved in any arbitration / Dispute / Civil suit etc.
- (10). The firm should clearly mention in its application the category of services for which it intends to apply.
- (11). Any other document or information, which is considered necessary for shortlisting.
- (12). In case of Joint Venture, the application be moved accordingly.
- (13). A set of documents (including inter alia evaluation criteria, instruction for preparation of shortlisting documents and list of documentary evidence required for shortlisting) are available in the office of undersigned and can be obtained on any working day during office hours on Cash / Pay Order in the name of Managing Director-PKHA of Rs.1000/- (non-refundable).

These documents can also be downloaded from the official website of PKHA whereas a Pay Order of Rs.1000/- (non-refundable) on account of fee of the documents shall be annexed with application failing which the application will not be considered.

Complete documents containing the above information should be delivered to the office of the undersigned on the above address upto 1200 hrs of 25/07/2017 which shall be opened on the same date at 1230 hrs.
