1. Office of the Deputy Commissioner Abbottabad invites sealed Bids from eligible Firms/Contractor Registered with Pakistan Engineering Council and also enlisted in the office of C&W Department Government of Khyber Pakhtunkhwa in relevant category in accordance with KPPRA procurement rules 2014 on single stage two envelopes.
2. Tender will be opened in the office of undersigned on 04.07.2017 at 14:00 hours in the presence of contractors or their representatives and members of Project Execution Committee.

1. Bid documents including Tender For, BOQ and instruction to bidders can be downloaded upto one day prior to the opening date from (C&W website (www.cwd.gkp.pk)).
2. Original Bid Security in the shape of Call Deposit in the name of Deputy Commissioner, Abbottabad shall accompany the financial bid. If any bid found without CD as prescribed, the bid shall be treated as "Non responsive" and the contractor shall be recommended to competent authority for debarring for onward tendering.
3. According to Provincial Government Notification No.KPPRA /M&E/Estt/1-5/2016 dated 24.5.2016 the Contractors/Bidders who quote their bids/rates more than 10% below the Engineer's Estimate shall submit an additional Security in the form of call deposit equal to 8% of the bid cost after commencements of work by the successful bidder 8% call deposit may be replaced with a bank guarantee of the same amount from the scheduled bank.
4. The additional security shall be released to the contractor in four installments i.e 25% to be released after completing 25% of the project, 50% to be released upon 50% completion, 75% to be released upon 75% completion and the remaining amount to be released after completion of the project. In case the bidder quotes more than 10% below the tender cost (Engineer's Estimate) and the bid is not accompanied by the additional security then the bid shall be considered as "Non-responsive" and the 2nd lowest bidder and so on will be considered accordingly.
5. The Contractors/firms shall quote their rates on ABOVE/BELOW SYSTEM on BOQ/MRS-2016.
6. The bidders are required to send their bids (Technical & Financial) through courier in duplicate in separate envelopes clearly marked as Original & Duplicate. The Original be sent to the Deputy Commissioner Abbottabad and the Duplicate to Superintending Engineer C&W Circle Abbottabad. Both the Original & Duplicate bids shall reach the concerned office before closing date and time.
