**NOTICE FOR PRE-QUALIFICATION**

1. Applications for prequalification under Rule-16 of KPPPRA Rules-2014 are invited from interested firms having enlistment in PKHA (for year 2017-18) of the required category and financial limit for the following specific contracts to be executed by PKHA:

**WIDENING & IMPROVEMENT OF TARNAWA KOHALA BALA ROAD (35 KM), DISTRICT HARIPUR SH:**

- Package-I (9-km) (estimated cost Rs. 543.080 million)
- Package-II (9-km) (estimated cost Rs. 678.696 million)
- Package-III (9-km) (estimated cost Rs. 801.434 million)
- Package-IV (8-km) (estimated cost Rs. 656.948 million)

2. Proposal shall contain but not limited to the following:

- a) A letter of intent addressed to Managing Director-PKHA.
- b) The title page of brochure shall also contain the nomenclature of the work for which the bidder intends to apply.
- c) Complete profile of the company.
- d) Detail of similar nature works completed during last 05-years supported by completion certificates and work orders of Executing agencies concerned.
- e) Detail of personnel and Machinery (Tools, Plants & Equipments etc) verified from the Executive Engineers concerned on Stamp Papers or supported with the purchase document / registration of regulatory Department concerned.
- f) Particulars of technical staff / engineers and their agreement on stamp paper with the firm together with their qualification. Affidavit to the effect that the said personnel shall be made available for the job should also be given alongwith their registration number of PEC (In case of graduate engineer).
- g) Financial soundness supported by annual audit reports for the last 03 years.
- h) Affidavit regarding non-blacklisting of firm.
- i) Detail of litigation and arbitration cases (if any) in which the contractor / firm is involved.
- j) Income Tax return certificate for latest year and NTN.
- k) Any other document or information, which is considered necessary for pre-qualification.

3. A set of pre-qualification documents (including inter alia evaluation criteria, instruction for preparation of firm's brochure and list of documentary evidence required for pre-qualification) are available in the office of undersigned and can be obtained on any working day during office hours on Cash / pay in the name of Managing Director-PKHA of Rs.1000/- (non-refundable) against each package. These documents can also be downloaded from the official web site of PKHA whereas a Pay Order of Rs.1000/- (non-refundable) on account of fee of the documents shall be annexed with application failing which the application will not be considered.

4. Proposals should contain the registration with PEC valid upto 30/06/2018.

5. Separate proposal sealed in separate envelope should be submitted against each package.

6. Sealed proposal should reach the undersigned upto 12:00 Noon on 26/02/2018 through courier services, which will be opened on the same date at 12:30 P.M.
