- 3. The work may be completed in stipulated period and technical sanction from the competent authority must be obtained before commencement of the work. The work order shall only be issued after fulfillment of all codal formalities.
- 4. The contractor may be directed to sign the contract agreement and the work shall commence after availability of funds.
- The Executive Engineer while issuing the work order will also specify the quarry/sources of the basic materials to the contractor so as to ensure good quality of the work.
- Professional tax/income tax and stamp duty shall be recovered from the contractor as per rules.
- The Procurement Committee shall be responsible for correctness and validity of the Contractor's enlistment with the Department & PEC and transparency of bidding.
- 8. Each payment will be supported by Material Test Result. A test profile may be maintained for the project.
- Procurement Committee shall ensure verification of call deposit, additional security and performance guarantee before issuance of work order.
