Pakhtunkhwa Highways Authority Government of Khyber Pakhtunkhwa invites sealed bids for collection of toll tax for the below Toll stations from the approved Toll Tax Contractors or any other individual registered with Income Tax Department, can participate in the auction after depositing **Registration fee of Rs. 20,000/- (Non-Refundable)** (in shape of CDR) for the current contracts only along with the bid.

- The bidders will have to submit 2% Earnest Money, Cost of Tender Form, Registration Fee accompanying 10% Additional Security as mentioned above along with bid in shape of call deposit in favour of Managing Director Pakhtunkhwa Highways Authority Peshawar, from a scheduled Bank of Pakistan payable in Peshawar Branch, failing which, bid will be considered as **“Non-Responsive”**.

4. Bidders who were awarded contracts of previous year Toll Tax Collection Rights, will have to submit a certificate from the concerned Deputy Director PKHA regarding satisfactory performance with their bids.
5. The Bidders should be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA). In case of non-registration upto the submission date and time the bid will be considered as, "**Non-Responsive**".
6. The bidder will submit the Financial Bid and other documents in 2 separate envelopes. 2% bid security, additional security, Registration Fee & Cost of tender documents, shall be sealed in one envelop clearly marked as "Bid Security" and shall be put in one envelope and other documents in another envelope.
7. The Bidders who were in litigation with the Authority or any amount is outstanding against them shall not eligible to participate in the bidding process until litigation cases are being withdrawn & outstanding dues are being recovered.
8. Sealed bids with sticking tap (not with stapler) of courier or by bidder however, the openable, face should be fully covered by sticking tap to make the envelope sealed. Any lapse in this regard will make your bid, "**Non-Responsive.**" bids are required to be sent through courier / urgent mail service (UMS) upto **12:00 noon** of **19-05-2021**, which will be opened the same day at **12:30 pm** in the presence of the participant bidders or their representatives.
9. If connivance, pooling, ring or any kind of graft is reported, then the bid will be cancelled and the bidders will be debarred.
10. The auction will be held in camera under video recording.
11. The successful bidder will have to deposit all Government taxes on prescribed rates fixed time to time by Government, of the bid cost within 7 days of the approval of the bid. Otherwise, the bid will be cancelled and the bid security will be forfeited in the favour of Government.
12. A Pre-bid meeting will be held in the office of the undersigned on **10/05/2021 at 11:00 am** for clarification of bidding documents / evaluation criteria or other related information regarding the work.
13. The procuring entity may reject all bids at any time prior to the acceptance of a bid. The procuring entity shall upon request, communicate to any contractor who submitted a bid, the grounds for rejection of all bids.
14. The Successful bidder will have to deposit entire bid amount in 12 installments payable in advance of each month and also submit postdated cheques of the installment amounts in advance before taking over the rights for collection of tolls.
