NOTICE INVITING E-BIDDING SYSTEM**

The C&W department office of the “Executive Engineer C&W Highway Division Kohat” Govt. of Khyber Pakhtunkhwa invites electronic bids from the eligible firms/bidders in accordance with KPPRA Procurement Rules 2014 on “Single Stage Single Envelope Procedure” for the works mentioned below. The bidders should be registered with KPPRA & Pakistan Engineering Council (PEC) for the Year 2020-21 in relevant category & field of Specialization, Enlisted with Communication & Works Department.

1. Bidding documents and instruction to bidders can be downloaded from C&W website (www.cwd.gkp.pk) as well as KPPRA website (www.kppra.gov.pk) before the submission time.
2. Bidders who submitted their financial bids without a valid Call Deposit will be debarred from participating in bidding process.
3. Financial bid shall be filled online. Complete bids must reach the concerned offices on or before the fixed date/ time. **The C.D.R or Additional Security in the shape of call deposit (if required) shall be enclosed in sealed envelope in the Financial Bid Proposal.**
4. Bid security of the 1st, 2nd and 3rd lowest Electronic Bidder for the specific work will be retained by the Department till the approval of bids.
5. Pay Order is hereby non-acceptable bid vide KPPRA Notification No.KPPRA/M&E/Estt:/1-12/2017-18 dated 05-04-2018.
6. Bid Security 2% with stamp duty of the Estimated Cost in the shape of call deposit in (original) should be enclosed along-with bidding documents.
7. As per KPPRA Act 2012 regulation No XII 2021 issued vide notification no SRO (12)/vol:1-20/2020-21 dated 21/04/2021.
 - a) The contractors quoting their bides more than 10 % below on engineer estimate shall submit an additional bid security equal to 8% of the bid cost along with the 2% bid security at time of bid submission.
 - b) If the successful bidder who quoted rate more than 10 % below on the engineer estimate and has repudiated the contract, the entire bid security deposit i.e 2 % of bid security along with 8 % of additional security shall be forfeited in the favour of Govt.
 - c) If the successful bidder who quoted rate more than 10 % below on the engineer estimate and has repudiated the contract for three different times in different bids during same fiscal year, then entire security deposit i.e (2 +8)% shall be forfeited in the favour of Govt and the contractor shall also be proceeded for blacklisting for a period of five years.
8. All Bidders are required to be Registered with the Khyber Pakhtunkhwa, Revenue Authority, Established under the Khyber Pakhtunkhwa, finance act, 2013 (Khyber Pakhtunkhwa, Act No. Xxi of 2013), for works, Consulting and Non-Consulting Services as listed in schedule-ii of the act ibid, with Pakistan Engineering Council (P.E.C) and KPPRA.
9. Venue of bids opening is office of the Executive Engineer C&W Highway Division Kohat.
10. The Bidder should have the relevant PEC specialization code, without which the bid will not be acceptable.
