INSTRUCTION TO BIDDERS (PRE-QUALIFIED CONTRACTORS/FIRMS)

2. As per KPPRA Notification No.1973-85 dated 21st of April 2021 that:
If the contractors quoted their bids more than 10% Below on the Engineer Estimate shall submit an additional Bid Security equal to 8% of the bid cost along with the 2% Bid Security at the time of bid submission.
- 2- The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as no MRS items.
- 3- Financial Bid shall be filled online, call deposit must be reached to this office on or before the fixed date/time.
- 4- Any electronic bidder who provides un-correct information shall stand dis-qualified and de-barred.
- 5- Call Deposit of schedule bank shall be acceptable.
- 6- Financial bid will be opened after 30-minutes of closing time in the presence of bidder/their representative who chose to be present.
- 7- Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bids.
- 8- All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act, 2013, otherwise he will not be entitled to participate in tendering process.
