#### INSTRUCTION TO BIDDERS (PRE-QUALIFIED FIRMS / CONTRACTORS)

- As per KPPRA Notification No. 1973-85 dated 21<sup>st</sup> of April, 2021 that:  
"If the contractors quoted their bids more than 10% Below on the Engineer Estimate shall submit an additional Bid Security equal to 8% of the bid cost alongwith the 2% Bid Security at the time of bid submission".
- The bidders are required to quote their rates above or below on BOQ/MRS System on both MRS as well as NSI items.
- Financial Bid shall be filled online, call deposit must be reached to this office on or before the fixed date / time.
- Any electronic bidder who provides un-correct information shall stand disqualified and de-barred.
- Call Deposit of schedule bank shall be acceptable.
- Financial Bid will be opened after 30-minutes of closing time in the presence of bidder / their representative who chose to be present.
- Bid Security of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest electronic bidder for the specific work will be retained by the Department till the approval of bids.
- All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act, 2013 otherwise he will not be entitled to participate in tendering process.
- Pay Order will not be acceptable as per KPPRA Rules.
