Executive Engineer Building (Division, District Charsadda), Government of Khyber Pakhtunkhwa invites electronic Bids from the eligible firms/bidders in accordance with KPPRA procurement rules 2014 on single stage Single envelope procedure for the following works:

1. Bid documents and instruction to bidders can be downloaded up to one day prior to the opening date from C&W web site ([www.cwd.gkp.pk](http://www.cwd.gkp.pk)).
2. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, Enlisted with C&W Department & PEC in Relevant category /Specialty
3. As per KPRA notification No. KPPRA/M&E/Estt:/17/2019-20 dated 12/06/2020 the following condition will be applicable in addition to mention already given on C&W website ([www.cwd.gkp.pk](http://www.cwd.gkp.pk)).
- i. The award of contract shall be on the basis of above / below engineer estimate on MRS instead of item rate basis.
4. As per KPRA notification No. SRO(12)/Vol:1-20/2020-21/2973-85 dated 21/04/2021 the additional Security shall be submitted by the bidders as under.
  - a. The Contractors quoting their bids more than 10% below engineer estimate shall submit an additional bid security equal to 8% of the bid cost alongwith the 2% bid security at the time of bid submission.
  - b. If the successful contractor who has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the contract, the entire security deposit i.e. 2% bid security alongwith 8% additional bid security shall be forfeited in favour of the Government.
  - c. If the successful contractor who has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the contract for three different time in different bids during the same fiscal year, then the entire security deposit i.e (2+8)% shall be forfeited in the favour of the Government and the contractor shall also be proceeded for blacklisting for a period of five years.
5. Bid shall accompanied with 0.03% of E/Cost as tender entry fee in shape of separate CDR which is non refundable.
