

***(Single Stage Single Envelope E-Bidding System)***

Pakhtunkhwa Highways Authority (PKHA) invites Electronic Bids from eligible firms / contractors in accordance with KPPRA Procurement Rules 2014 on, “*Single Stage Single Envelope*” E-Bidding Procedure for the following works. The bidders should be registered with Pakistan Engineering Council (PEC) for the Year 2021-22 in relevant Category & Field of Specialization. The firms already enlisted with PKHA having adequate financial soundness, relevant experience, personnel capabilities, required equipments and other requirements as included in ITB can participate in the tender.

**(SINGLE STAGE SINGLE ENVELOP E-BIDDING SYSTEM CONDITIONS/ITB)**

1. Bid Security (**2% of the Estimated Cost**) in the shape of Call Deposit (CDR) or Bank Guarantee (in original) shall be provided before closing time and must be uploaded on E-Bidding System.
2. Cost of Tender form (@0.03% of Estimated Cost) (Non-refundable) in the shape of Call Deposit (CDR) (in original) shall be provided before closing time, vide Notification No. SO(B)/1-102/CMD/CS/PBC/2020-21/C&WD dated 12/04/2021.
3. Financial Bid should be submitted online / electronically and CDR (in original) & other relevant documents should reach in this office in sealed envelope on or before the closing date & time.
4. Electronic Bids will be displayed Online on E-Bidding System after 30 minutes of closing time in the presence of bidders / their representatives who chose to be present.
5. The contractors quoting their bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security equal to 8% of the bid cost along with the 2% bid security at the time of bid submission.
6. If the successful contractor who has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the contract, the entire security deposit i.e. 2% bid security along with 8% additional bid security shall be forfeited in favor of the Government.
7. The bidder are required to quote their rates (electronically) "ABOVE / BELOW / AT PAR" for both priced BOQ / Engineer Estimate based on MRS -2020 applicable and NSI Items as well. Only two digits after the decimal point shall be considered for evaluation purpose.
8. Any bidder who provides incorrect information shall stand disqualified & de-barred.
9. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of Work Order.
10. Electronic Bids validity period is 90-days.
11. Successful Bidder should sign the agreement with the department within Twenty Eight (28) days after issuance of Work Order.
12. Call Deposit and bank guarantee of Scheduled Banks shall be acceptable.
13. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will declared through open draw
14. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
15. Bid security of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders for the each work will be retained by the Department till the approval of bid.
16. The successful bidder shall be subjected to all admissible taxes including stamp duty, service charges, sales tax & any other at prevailing rates.
17. The Contractor will deposit Performance Security (*In shape of CDR / Bank Guarantee (valid for one year in case of Bank Guarantee)*) within fourteen (14) days after receipt of Letter of Acceptance, in case the contract value is equal to or exceeds Rs. 20.00 million

*All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA) established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI or" 2013), for works, consulting and non-consulting services as listed in Schedule – II of the Act ibid.*
