- I. The firms should have valid registration of PEC having relevant codes and with Khyber Pakhtunkhwa Revenue Authority (KPRA).
- II. A firm / joint venture will be selected for the services under quality cum cost based selection (QCBS) method as per procedure / criteria described in the request for proposal (RFP) documents.

You are invited to submit a comprehensive Technical proposal in English (Original + one copy) and a financial proposal (Original + one copy) separately for each work mentioned above for the services required under the terms of references (TOR's) latest by **22/10/2021 till 12:00 Noon which will be opened on the same day at 12:30 PM**. The original & copy of the proposal shall be sealed in separate envelopes and marked as original and copy. Both these envelopes shall be put in one sealed envelope and addressed to Managing Director PKHA.
- IV. RFP documents / TOR's are available in the office of the undersigned and can be obtained on payment of Rs. 1000/- (non-refundable) in form of CDR on any working day during office hours. RFP documents can also be downloaded from the official web site of PKHA whereas a CDR of Rs.1000/- (non-refundable) on account of fee of the RFP documents shall be put in technical envelop failing which the proposal will be considered as non-responsive.
- V. The successful firm shall be subjected to all admissible taxes including stamp duty, service charges, sale tax and any other at prevailing rate.
