3. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority for works, consulting and non-consulting services as listed in schedule-II of the Khyber Pakhtunkhwa Finance Act, 2013 Act No. XXI of 2013".
4. Action will be taken against the bidders who submit their financial bids without a valid Call Deposit
5. The scan copy of Call Deposit must be attached with technical bid on E-Bidding System. In case of failure the bidder will be considered as non responsive.
6. As per KPPRA amended Notification No. S.R.O.(13)/Vol:1-21/2021-22 dated 15/09/2021, the Contractors quoting their bids more than 15% below on Engineer's Estimate shall submit Additional Bid Security alongwith the 2% bid security at the time of bid submission otherwise the bids will be considered as "Non-responsive" and further action will be taken in the light of above notification. Furthermore all other requirements for bids, quoted below than 30% on Engineer Estimate, shall be obligatory upon bidders as per above notification.
7. The interested bidder must accompany the relevant experience / certificates for the said work.
8. As per KPPRA Rules 0.03% non-refundable bidding entry fee on Estimated Cost in shape of Call deposit.
