

You are invited to submit a comprehensive Technical proposal in English (Original + one copy) and a financial proposal (Original + one copy) for the services required under the terms of references (TOR's) latest by 26 / 10 / 2021 till 12:00 Noon which will be opened on the same day at 12:30 P.M. The original & copy of the proposal shall be sealed in separate envelops and marked as original and copy. Both these envelops shall be put in one sealed envelop and addressed to Managing Director PKHA.
- IV. RFP documents / TOR's are available in the office of the undersigned and can be obtained on payment of Rs. 1000/- (non-refundable) in form of CDR on any working day during office hours. RFP documents can also be downloaded from the official web site of PKHA whereas a CDR of Rs.1000/- (non-refundable) on account of fee of the RFP documents shall be put in technical envelop failing which the proposal will be considered as non responsive.
