- The expenditure involved will be met out from the Sanctioned budget under the function cum-object classification04-Economic Affairs-045-Construction & Transport-0452-Road Transport-045202-Highways 2. Road & Bridges (NC 12064) under Grant 056 during current financial year.
- The Administrative Approval does not constitute any sanction to design rates provided in the rough cost estimate. The suitability of design & financial responsibility of the rates rests with the authority competent to accord technical sanction to the cost estimate.
- The sanctioning authority shall allow appropriate rates after observing all codal formalities/ standing instructions regarding schedule of rates and financial regularity. The work shall be taken in hand after 4. release of funds and proper technical sanction of the cost estimate.
- As per decision of the Competent Authority dated 22-09-2015 that Road should not have less than 18 feet 5. width except in built-up area or in the area where R.O.W is restricted and require acquisition of land.
