INSTRUCTIONS TO BIDDERS
(Single Stage Single Envelop E-Bidding System)**

1. Financial proposal should accompany the following:

Bid Security 2% of the Engineering Estimate in the shape of call deposit should be submitted with the Financial Bid. The contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their financial bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the financial bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.

Similarly, a contractor quoting bid more than 20% below shall submit with his financial bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineers Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.

In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons.

2. A joint venture (JV) of Contractors will also be allowed to participate in the Bidding. The JV agreement should be attached with the Technical Proposal. The JV should be registered with the C&W well before the tender opening date for awarding Users name & password

3. Enlistment Order of C&W Department (photocopy)

4. Renewal of registration for CFY 2024-25

5. National Identity Card (CNIC Photocopy)

6. Valid Pakistan Engineering Council registration copy for current calendar year.

7. Documents showing general capabilities, financial soundness, general and relevant experience record, personnel capabilities, equipment capabilities and Income Tax / NTN Certificates, etc.

8. Any other document to support the technical bid.

9. After commencement of work by the successful bidder, the additional security shall be released to the bidders in four installments i.e. 25% to be released after completing 25% of the project and so on. In case the bidder quotes lower than 15% below the Engineer's Estimate and the bid is not accompanied by an additional bid security then bid shall be considered as non-responsive.

10. All the bidding will be through E-bidding system. Bid should be in sealed envelopes and shall be submitted through courier before closing time.

11. In case a contractor quotes more than 30% below on Engineer Estimate, the procuring entity shall, in addition to additional security, Require the contractor to produce detailed rate analysis of his bid price in relation to any or all the items of bill of quantities, scope of work, allocation of risks and responsibilities and/or any other requirements of the bid solicitation document. The contract shall be awarded to the lowest evaluated bidder who has satisfied the procuring entity on rate analysis. However, if the procuring entity determines that the contractor has failed to demonstrate its capability to execute the contract at the offered price, the matter shall be referred to the next higher authority for rejection of the bid on the basis of being financially unviable.

12. The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as Non-MRS items.

13. Bid shall be filled online. Complete bid must reach the concerned offices on or before the fixed date/ time. The CDR or Additional Security (if required) shall be enclosed in the Bid Proposal.

14. Any Electronic Bidder who provides incorrect information shall stand disqualified & de-barred.

15. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of LOA.

16. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013(Khyber Pakhtunkhwa Act No. XXI of 2013), for works consulting & non-consulting services as listed in Schedule-II of the Act ibid.

17. Electronic Bids validity period is 90 days.

18. Successful Bidder should sign the agreement with the department within (28) days after issuance of LOA.

19. Call Deposit of Scheduled Banks shall be acceptable.

20. The submission of CDR by the contractor will be mandatory along with a verified copy of CDR from the concerned Bank should be provided with the Bid Proposal.

21. If the evaluated electronic bid costs of two or more than two bidders are equal, then the successful bid will be declared through draw.

22. Bid will be opened after 30 minutes of closing time in the presence of bidders/ their representatives who choose to be present.

23. The employer has the authority to reject any bid or all the bids assigning cogent reasons.

24. Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bid.
