Financial proposal should accompany the following: 1.

Similarly, a contractor quoting bid more than 20% below shall submit with his financial bid an additional security on Engineer's Estimated cost country. Engineer's Estimated cost equal to the differential amount of submitted bid and Engineers Estimate along with detailed rate analysis. In case of more than 20% below shall submitted bid and Engineers Estimate along with detailed rate analysis and / rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bidder and submitted along with such non-responsive bid shall be considered as non-responsive. All the said bid shall be considered as non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered associated. so on will be considered accordingly.

In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may dealer and record the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons.

- A joint venture (JV) of Contractors will also be allowed to participate in the Bidding. - After commencement of work by the successful bidder, the additional security shall be released to the bidders in four installments i.e. 25% to be released. installments i.e.25% to be released after completing 25% of the project and so on. In case the bidder quotes lower than 15% below the Englected 5. 9. than 15% below the Engineer's Estimate and the bid is not accompanied by an additional bid security then bid shall be considered as non-constant.
- All the bidding will be through E-bidding system. Bid should be in sealed envelopes and shall be submitted through courier before closing time. 10.
- In case a contractor quotes more than 30% below on Engineer Estimate, the procuring entity shall, in addition to additional security. Paradia the additional security, Require the contractor to produce detailed rate analysis of his bid price in relation to any or all the items of hill of quantities. 11. items of bill of quantities, scope of work, allocation of risks and responsibilities and/or any other requirements of the bid solicitation document. The contract shall be awarded to the lowest evaluated bidder who has satisfied the procuring entity on rate analysis. However, if the procuring entity determines that the contractor has failed to demonstrate its capability to execute the contract at the offered price, the matter shall be referred to the next higher authority for rejection of the bid on the basis of being financially unviable.
- The bidders are required to quote their rates above or below on BOQ/MRS system on both MRS as well as Non-MRS 12.
- Bid shall be filled online. Complete bid must reach the concerned offices on or before the fixed date/ time. The CDR 13. or Additional Security (if required) shall be enclosed in the Bid Proposal.
- Any Electronic Bidder who provides incorrect information shall stand disqualified & de-barred. 14.
- Time allowed for the completion of the work as specified in the NIT shall start from the issuance of LOA. 15.
- All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the 16. Khyber Pakhtunkhwa Finance Act, 2013(Khyber Pakhtunkhwa Act No. XXI of 2013), for works consulting & nonconsulting services as listed in Schedule-II of the Act ibid.
- Electronic Bids validity period is 90 days. 17
