(SINGLE STAGE SINGLE ENVELOPE E-BIDDING SYSTEM CONDITIONS/ITB)

1. Bid Security (2% of the Estimated Cost) in the shape of Call Deposit (CDR) or Bank Guarantee (in original) in favor of Managing Director PKHA shall be provided before closing time and must be uploaded on E-Bidding System.
2. The contractors quoting their bids more than 10% below up to 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
3. The bidders are required to quote their rates (electronically / in form of bids) "ABOVE / BELOW / AT PAR" for Schedule & Non-Scheduled Items based on MRS 2024 (1st Annual). Only two digits after the decimal point shall be considered for evaluation purpose.
4. Any bidder who provides incorrect information shall stand disqualified & de-barred.
5. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of Work Order.
6. Electronic Bids validity period is 90-days.
7. Successful Bidder should sign the agreement with the department within Fourteen (14) days after issuance of Letter of Acceptance.
8. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will declare through open draw.
9. The employer has the authority to reject any bid or all the bids assigning cogent reasons.
10. The bid securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of validity of Bid Security whichever is earlier.
11. The successful bidder shall be subjected to all admissible taxes including stamp duty, service charges, sales tax & any other at prevailing rates.
12. The Contractor will deposit Performance Security (*In shape of CDR / Bank Guarantee valid for one year in case of Bank Guarantee*) within fourteen (14) days after receipt of Letter of Acceptance.
13. All the bidders must be on Active Tax Payers List (ATL) with FBR.

All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA) established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI or" 2013), for works, consulting and non-consulting services as listed in Schedule – II of the Act ibid.
