

- Legible scanned copy of Bid Security shall be submitted electronically along with the bid on E-Bidding system.
- All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority under the Khyber Pakhtunkhwa Finance Act, 2023 Act No.XXI of 2013.
- The financial bid will be opened after the approval of Technical Bid from the Competent Authority.
