The Procuring Entity, Executive Engineer Maintenance-I C&W Department Peshawar, invites sealed bids from eligible firm/contractor enlisted with C&W Department, licensed by the Pakistan Engineering Council in the appropriate category and dully pre-qualified with the then Maintenance-I C&W Department for the work as under:-

TERMS & CONDITIONS:-

1. Bid Documents Instruction. Condition to bidders can be downloaded up to one day prior to the opening date from C&W web site www.cwd.gkp.pk. A Complete set of Bid Solicitation Documents may be obtained on submission of a written application one day prior to the opening date from office of the undersigned otherwise bids submitted without these documents will be non-responsive.
2. Original Bid Security in the shape of Call Deposit in the name of Executive Engineer Maintenance-I C&W Department Peshawar shall accompany the bid.
3. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established Under the Khyber Pakhtunkhwa Finance Act 2013 (Khyber Pakhtunkhwa No. XXI of 2013) for works, consulting and Non-consulting services as listed in Schedule-II of the Act and the bid.
4. Each bidder shall submit his bid through sealed cover as under:-
 - (a) ORIGINAL and each copy of the bid shall be separately sealed and put in separate envelopes and marked as such.
 - (b) The Envelope containing the ORIGINAL and copies will be put in one sealed envelope and addressed to Executive Engineer Maintenance-I C&W Department Peshawar.
5. The item rate system is replaced by Above/Below system on BOQ based on Market Rate System.
6. Bid will be valid for Ninety (90) days.
7. If the bid rate / cost of two or more than two bidders are same then the successful bid will be decided through a toss.
8. All Federal/Provincial duties/Stamp duties/Taxes will be recoverable as per directions of the Government issued from time to time.
9. Execution of Work will be subject to release / availability of fund.
10. The Competent authority reserves the right to reject any or all the tenders by assigning the cogent reason after consultation with authority at any time prior to the award of contract.
11. All other terms & conditions can be seen on official website of the C&W Department or from the office of the undersigned on any working day during office hours. A part of Notice Inviting Tender (NIT). Moreover, the bidder's entry fee @ 0.03% of tender cost may be revived, and collected along-with earnest money, which will be non-refundable.
12. The Contractors quoting the bids up to a limit of 15% below Engineer Estimate shall submit bid security to the extent of 2% of Engineer Estimate only.
13. Additional bid security Should be received as per Khyber Pakhtunkhwa Public Procurement Regulatory Authority Notification No. S.R.O (13) / Vol: 1-21/2021-22 dated 15.09.2021.
 - i. The Contractors quoting the bids up to a limit of 15% below Engineer Estimate shall submit bid security to the extent of 2% of Engineer Estimate only.
 - ii. The contractors quoting their bids more than 15% below on Engineer's Estimate shall submit along with their bid an Additional Security to the extent of their bid/rates more than 15% below on Engineer Estimate in the form of percentage.
 - iii. In case the bidder quotes more than 15% below the Engineer Estimate and the bid is not accompanied by the Additional Security then the bid shall be considered as non-responsive and the 2nd lowest bidder and so on will be considered accordingly.
 - iv. In case a contractor quotes more than 30% below on Engineer Estimate, the procuring entity shall in addition to additional security, required the contractor to produce detailed rate analysis of his bid price in relation to any or all the items of bill of quantities, Scope of work allocation of risks and responsibilities as per / or any other requirements of the bid solicitation document. The contract shall be awarded to the lowest evaluation bidder who has satisfied the procuring entity on rate analysis. However, if the procuring entity determines that the contractor has failed to demonstrate its capability to execute the contract at the offered price, the matter shall be referred to the next higher authority for rejection of the bid on the basis of being financially unviable.
 - v. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity fresh.
 - vi. After commencement of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank, if the already deposited security is not the form of bank guarantee.
 - vii. The Additional Security shall be released to the contractor in four installments that is 25% to be released upon completion of 25% of the project, 50% to be released upon completion of 50% of the project, 75% to be released upon completion of 75% of the project and the remaining amount to be released after completion of the project.
 - viii. All the previous orders, instructions and regulations issued regarding Additional Security shall stand superseded.
 - ix. The contractors having solar system code can apply for the work at serial No.6 above.
