- 1. Bid documents and instruction to bidders can be downloaded up to one day prior to the opening date from C&W web site (www.cwd.gkp.pk).
- 2. As per Clause 37 (A) of KPPRA Rules, all bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority.
- 3. As per KPPRA notification No. SRO (13)/Vol: 1-21/2021-22/5335-48 dated 15/09/2021 the additional Security shall be submitted by the bidders as under.
- a. The contractor quoting their bids upto a limit of 15% below Engineer Estimate shall submit bid security to the extent of 2% of Engineer Estimate only.
- b. The contractors quoting their bid more than 15% below on Engineer Estimate shall submit along with their bids an Additional Security to the extent of their bid/rates more than 15% below on Engineer estimate in the form of percentage.
- c. In case the bidder quotes more than 15% below the Engineer Estimate and the bid is not accompanied by the Additional Security then the bid shall be considered as non responsive and the 2nd lowest bidder and so on will be considered accordingly.
- d. In case a contractor quotes more than 30% below on Engineer Estimate, the procuring entity shall, in addition to additional security, require the contractor to produce detailed rate analysis of his bid price in relation to any or all the items of bill of quantities, scope of work, allocation of risks and responsibilities and/or any other requirements of the bid solicitation document. The contact shall be awarded to the lowest evaluated bidder who has satisfied the procuring entity on rate analysis. However, if the procuring entity determines that the contractor has failed to demonstrate its capability to execute the contact at the offered price, the matter shall be referred to the next higher authority for rejection of the bid on the basis of being financially unviable.

4. Bid shall accompanied with 0.03% of E/Cost as tender entry fee in shape of separate CDR which is non refundable.
