
**NOTICE INVITING E-BIDDING**

2. All interested eligible bidders shall deposit their CDR in the name of procuring entity prior to the closing date of bid submission.
3. In case, no security deposit is credited the bid shall be considered non-responsive and will be rejected.
4. Bidding shall be done on "Above/Below" system on BOQ/Engineers Estimate. Based on the MRS applicable.
5. The financial bid opening date will be intimated to all concerned after finalization of Technical Evaluation by the procurement committee.
6. The bid should be submitted through courier sealed in envelop before closing date and time.
7. Instructions regarding Bid Security / Additional Security etc. mentioned in Instructions to Bidders (ITB) of Bidding Documents, vide Assistant Director(M&E) KPPRA Notification No.SRO(14)/Vol:-1-24/2021-22 dated 10<sup>th</sup> May, 2022.
8. A copy of Technical Proposal in the required format is mandatory and to uploaded as part of E-Bidding before submitting Financial Bids.
9. Tender form fee (non-refundable) @0.03% on tender cost in shape of Call Deposit should be accompanied with technical bid.

A complete set of bid documents / criteria for the works should be obtained by an interested eligible bidder on submission of a written application, from the office of undersigned on any working day / hours on or before 23.08.2023 on payment of Rs.2000/-(non-refundable) otherwise his bid will not be entertained.
