- The procuring entity shall disqualify a contractor if it finds, at any time, that the information submitted by him concerning his qualification as contractor was false and materially inaccurate or incomplete as per rule 43 of KPPRA rules 2014.
- The Procurement Committee shall be responsible for the Authenticity/verification of CDRs of all the participated bidders (Pay Order will not be acceptable as per KPPRA Rules).
- As per KPPRA rules 2014, Sub rule 45, the evaluation reports should be uploaded on department as well as on KPPRA website and also adhere to rule 36 (4).
