**CONSTRUCTION OF ROAD CONNECTING INDUS HIGHWAY (N-55) AT TAKE OFF BANNU LINK ROAD
WITH HAKLA - YARIK - D.I KHAN MOTORWAY (M-14)
THROUGH PUBLIC PRIVATE PARTNERSHIP (PPP)**

- 1- The Pakhtunkhwa Highways Authority (PKHA) Government of Khyber Pakhtunkhwa, consistent with its development objective, to enhance regional connectivity and connect far-flung areas with Pakistan's motorway network, particularly the southern region, has launched this project.**
- 2- Total Length of the Project is 42.3 km which will take off from Bannu Link road (N-55) and will terminate at Kallur Hakla-Yarik D.I. Khan Motorway (M-14). It will be class-2 highway, fenced and 2-Lane single carriage way.**
- 3- PKHA intends to undertake the Project through Public-Private Partnership ("PPP") wherein the private party will be responsible to design, finance, develop, construct, insure, operate, manage, improve, maintain the road throughout the concession period and transfer the project at the end of concession period to PKHA. During the concession period the Concessionaire shall have the exclusive right to collect toll fee and other revenue within the right of way (ROW) as specifically mentioned in the Request for Proposal ("RFP").**
- 4- PKHA shall provide land for construction of the Project free from encumbrances and may provide other support – to be detailed in the RFP.**
- 5- Expression of Interest ("EOI") is solicited from well reputed domestic as well as foreign firms, joint ventures and consortia having experience and capability of financing, designing, constructing, operating and maintaining highway/motorway projects in accordance with the evaluation criteria.**
- 6- Interested parties may obtain the Pre-Qualification ("PQ") document from office of the undersigned during office hours against a (non-refundable) fee of Rs 5,000/- (Pak Rupees five thousand only) (equivalent to US\$ 20.00), to be paid in shape of bank draft or pay order in favor of MD PKHA, or may download from PKHA website: <https://pkha.gov.pk/>**
- 7- Last date for submission of PQ Documents is 15th January 2026 at 1530 Hrs, which will be opened on the same day at 1600 Hrs.**
- 8- PKHA shall issue RFP to the pre-qualified party (ies) only. The RFP shall contain, inter-alia, instructions to bidder, detailed scope of work, draft concession agreement etc.**
- 9- The PKHA reserves the right to reject any or all applications of EOI by assigning cogent reason.**
