As evaluated and recommended by the Procurement Committee vide above referred letter, the bid costing **Rs:1.5557(M)** (Rupees One Million Five Hundred Fifty Five Thousand & Seven Hundred Only) based on the lowest rate AT PAR on Schedule items on Tender / BOQ Cost based on MRS 2024 (1<sup>st</sup> Qtr.), offered by **M/S Qazi Builders & Designers**, Government Contractor for the subject cited work is hereby approved on the basis of documents submitted by you and recommended by the Superintending Engineer C&W Circle Waziristan at Bannu, subject to fulfillment of all codal formalities, financial discipline and the following conditions:-

- 1) The Executive Engineer/Sub Divisional Officer, in-charge supervisory staff and shall be responsible for the execution of the work according to the specifications, approved scope of work authenticity rate provided in the BOQ and administratively approved P C-I/Cost Estimate.
- 2) Technical Sanction from the Competent Authority must be obtained before commencement of the work. The work order shall only be issued after fulfillment of all codal formalities.
- 3) The Contractor shall be directed to sign the Contract Agreement as per KPPRA Bidding Documents-2014 and be asked to submit work plan immediately for approval of the XEN.
- 4) The Superintending Engineer / Executive Engineer and Consultant (if any) while issuing of work order should specify the quarry/sources of the basic materials to the Contractor, so as to ensure good quality of work and also carrying out required material tests.
- 5) Professional Tax / Income Tax/GST and stamp duty shall be recovered from the Contractor as per rules / SROs in vogue.
- 6) The Executive Engineer/Head Clerk i.e. Procurement Committee shall be responsible for correctness of documents verification CDRs/Performance Guarantee, PEC registration, transparency of the bidding process and their authentication from entities concerned and validity of Contractor's enlistment with the Department before issuing of work order.
- 7) The Executive Engineer concerned shall be responsible for the specification and quantities indicated in the BOQ.
- 8) Tender Opening Committee will be held responsible for any error found in arithmetical calculations of quoted bids at any stage.
- 9) Prior approval of Competent Authority should be obtained for any variation from approved BOQ quantities and rates.
- 10) SDRs/CDRs as 2% Earnest Money of the lowest bidder "M/S Qazi Builders & Designers" Government Contractor should be verified from the concerned Bank, regarding the ownership of account and its verification before issuance of work order and make it part & parcel of the tender documents.
- 11) Each payment will be supported by material test results. A test profile may be maintained for the Project.
- 12) The Executive Engineer / SDO In-charge are responsible for correctness of rate analysis of Non Schedule item (NSI).
- 13) In case of Non Schedule items (NSI), the detail analysis must be approved from the Authority concerned under relevant clause of Contract Agreement before issuance of work order.
