Late bids will be rejected. The outer bid envelopes marked " <b>ORIGINAL BID</b> " and the inner envelopes marked " <b>TECHNICAL PART</b> " will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend, at the address mentioned above on <b>15 April 2026 at 11:30 hours</b> . All envelopes marked " <b>FINANCIAL PART</b> " shall remain unopened and will be held in safe custody of the Employer until the second public bid opening.
9	All Bids must be accompanied by a Bid Security: (i) <b>PKR 40.00 million</b> shall be in the form of an unconditional bank guarantee or CDR issued by a scheduled bank in favour of <b>Project Director, PIU, KP-RIISP, C&amp;W Department, Government of Khyber Pakhtunkhwa</b> and (ii) demonstrating the Bidder's plan to employ unskilled and semi-skilled labor from the local communities in the project area, in accordance with the requirements set forth in the bidding documents.
