 - (Understanding of assignment, approach, work plan, risk assessment & mitigation strategies.)
- Team Qualifications 60%
 - (CVs of key experts: Team Lead, Bridge Management Specialist, Software Engineer, Database Specialist, Training Specialist as per TOR requirements.)
- Firm's Experience 20%
 - (Relevant past projects, especially BMS/RAMS, government agency work, international standards experience.)
- **6.** Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. The rationale for association with brief specialties to enhance the qualification shall be mentioned with broad job description of each member of association (JV and/or sub-consultant). In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected. Interested consulting firms should provide information demonstrating they have the required qualifications and relevant experience to perform the services.
