In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered

5. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid

6. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such to bids or may advertise procurement opportunity afresh.

7. After commencements of work by the successful bidder the Procuring Entity may replace the Additional Security with a Bank Guarantee of the same amount from the scheduled bank; if the already deposited 8.
