GENERAL TERMS AND CONDITIONS.

- 1. Bid Solicitation Documents and Instruction to bidders can be obtained from the office of the undersigned on any working day or downloaded from C&W web site (www.cwd.gkp.pk) before the submission date/time.
- 2. A pre-bid meeting will be held on 24-11-2025 at 10:00AM in the office of the undersigned (C&W Division Malakand).
- 3. Cutting and overwriting in the bid documents shall not be acceptable.
- 4. Contractors will quote their rates electronically & upload the complete BOQ with their quoted rates prior to closing date & time. If the quoted rates and uploaded BOQs rates are different, then the bid will be considered as Non-Responsive.
- 5. As per KPPRA Notification No. S.R.0.(14)/Vol: 1-24/2021-22/6058-71 Dated Peshawar, the May 10th, 2022 regarding the Bid Security & Additional Security, clear instructions has been given in the said notification of KPPRA and the clauses shall be implemented on this bid.
- 6. The Contractors quoting their bids upto a limit of 10% below Engineer Estimate shall submit bid security @ 02% only of Engineer Estimate. The Contractor quoting their rate more than 10% below and upto 20% below of Engineer Estimate shall submit along with their bids 8% Additional Security of Engineer Estimated cost in addition to 02% bid security. If the bid is not accompanied with required amount of additional security then it well be considered non responsive and the 02% bid security shall be forfeited in favour of Government and 2nd lowest bidder and so on will be considered accordingly. The Contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer Estimated cost equal to the differential amount of submitted bid and Engineer Estimate alongwith detail rate analysis. In case of more than 20% below bids, If the bid is not accompanied by detail rate analysis and/or required additional security, then the said bid shall considered as non-responsive and all other securities with such non-responsive bid shall be forfeited in favour of Government and 2nd lowest bidder and so on will be considered accordingly, In case detail rate analysis submitted with bids is, in view of Procuring Entity not convincing, then Head of Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reason thereof.



- 7. Technical Evaluation will be carried out on the basis of (Experience, Record, Personal Capabilities, Equipment's Capabilities, Financial Soundness and audit Reports last year's etc) proper marking criteria as approved by competent Authority. Failing to fulfill passing criteria shall be considered as fail leading to disqualification of the bidder.
- 8. The bid security in shape of call deposit (Original) shall be kept sealed in the financial proposal. The bidder shall in addition, place an affidavit in the Technical proposal stating that a bid security amounting to 02% (percent) without indicating the figure in the letter, has been placed in the financial proposal or bid. Otherwise, the technical proposal will be considered non-responsive and will be returned to the bidder after being examined by the procurement committee.
- Financial bid (Electronic Bids) will be open in the office of C&W Division Malakand on later date and time which will be communicated through letter to technically qualified bidders only.
- 10. Detail of bid security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically along with E-bid i.e. BOQ and Detail Rate Analysis (if applicable) on the respective Field Tab on the E-PAD online system, failing which the bid will be consider Non Responsive and the Original copy of CDR should be submitted to the office of undersigned before the closing date & time.
- 11. Any bidder who provides false, or materially inaccurate or incomplete or do not send bid securities in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity / Executing Agency will recommend and sent cases for debarring / Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
- 12. Tender Fee @ 0.03% should be submitted separately in shape of Call Deposit in case if not found with other documents will be considered as Non Responsive.
- 13. No Pay Order and Bank Draft will be acceptable except Call Deposit of schedule Bank otherwise the bid will declare as non responsive.
- 14. Bid security of the 1st, 2nd & 3rd lowest electronic bidder for the specific work will be retained by this office till the approval of bids.
- 15. Bid not fulfilling any of the criteria as stated above and in the bidding documents will be declared as Non-Responsive.
- 16. The Employer has the authority to reject any E-bid or all the E-bids by assigning valid reason.
- 17. Electronic Bids will be displayed by online E-PAD System after 30-Minutes of closing time in presence of bidders/their representative.
- 18. Criteria for the work at Serial No.1 & 2 can be obtained from office of the undersigned during office hours on cash payment @ Rs.3000/-(Non-Refundable) upto 26-11-2025 at 12:00 PM.
