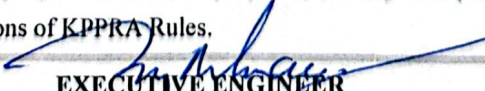

Government of Khyber Pakhtunkhwa through Communication & Works Department Peshawar invite applications from C&W shortlisted consultant for road sector having relevant PEC specialized service for the following works:

1. "F/S and Design of Mastuj Boroghul Pass Road (153) Km ADP No: 1295 / 250331 (2025-26)"
2. F/S and Design of Bridge Awi Miragram to Bragwal --- 1425 / 251465 (2025-26)

Terms & Conditions

1. The National Open Competitive bidding process will be adopted as stipulated in KPPRA Rules, 2014 (amended up to date).
2. The firms should have valid registration of PEC having relevant codes and with Khyber Pakhtunkhwa Revenue Authority (KPRA).
3. A firm/Joint venture will be selected for the services under quality cum cost-based selection (QCBS) method as per procedure / criteria described in the request for proposal (RFP) Documents).
4. Technical & Financial Proposal, separately proposals, duly completed and in conformity with Tender **RFP Documents must be submitted online through E-Pak Acquisition and Disposal System (e-PADS).**
5. Pre discussion meeting will be held on **Thursday October 30, 2025 at 11:00 AM.**
6. The interested Consultants will submit their proposals only on agreed format, for each work separately, **latest by 11/11/2025 till 12:00 PM Noon**, both in Soft & Hard form, Technical Proposal will be opened on the same date at 1:00 P.M in the presence of all firms or their authorized representatives who choose to attend the bid opening at the same address/date. The proposal shall be sealed in separate envelops and marked Technical & Financial proposal. Both of these envelops shall be put in one sealed envelope and addressed to the Executive Engineer C&W Division Upper Chitral.
7. RFP Documents/TOR are available in the office of the undersigned and can be obtained on any working day during office hours at least three (3) days before the closing date in cash payment of Rs. 5000/- (non-refundable). The RFP Doc is also available at C&W & KPPRA website (www.kppra.gov.pk).
8. The method for invitation of e-bid or proposal is through uploading PDF file.
9. Proposal including entries and record submitted on e-PAD found corrupt, un-readable or contains virus, it shall be rejected. Bid that are late, or submitted by other than specified mode will not be considered.
10. In case of official holiday on the day of submission / tender opening, next day will be treated as closing date.
11. The Competent Authority may reject all bid(s) or proposal(s) at any time prior to the acceptance of bid(s) or proposal(s), as per provisions of KPPRA Rules.
