- 1. Bid documents & instruction to bidder can be downloaded from C&W web site (<u>www.cwd.gkp.pk</u>) before be submission date & time.
- 2. Tender Fee shall be submitted in the shape of call deposit along with technical bid on E- bidding system.
- 3. The contractor quoting their bids upto a limit of 10% below Engineer Estimate Shall be submit bid Security @ 2% only of Engineer Estimate.
- 4. The Contractor quoting their bid more than 10% below upto 20% below on Engineer Estimate shall submit along with their bids 8% additional Security of Engineers Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered is non responsive & the 2% bid security shall be forfeited in favour of Govt: and the second lowest bidder and so on will be considered accordingly.
- (Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineers Estimated cost equal to the Differential amount of submitted bid and Engineer Estimate along with detailed rate of analysis) In case of more than 20% below bids, If the bid is not accompanied by the detailed rate analysis and / or required amount of additional security then, the said bid shall be considered is non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Govt: and the seconded lowest bidder and so on will be considered accordingly.
- 6. In case detailed rate analysis submit with the bid is, in view of the procuring Entity, not convincing, the Head of the procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- 7. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of the financial difference between such two bids or may advertise procurement opportunity afresh.
- 8. The Additional Security shall be released to the contractor in (4) Four installments that is 25% to be released upon completion of 25% of the project, 50% to be released upon completion of 50% of the project, 75% to be released upon completion of 75% of the project and the remaining amount to be released after completion of the project.
- The procuring entity may offer the contract to next lowest bidder after the diligence in the context of financial difference between such to bids & the market analysis in order to discourage cartel making and to protect public at large.
- 10. Pay order is not acceptable as per Notification No of KPPRA vide No. KPPRA/M&E/Estt: /1-12 /2017-18 dated

5-4-2018.

- 11. Scanned copy of bid security i/c Tender entry Fee shall be submitted electronically along with Technical bid on E-bidding System.
- 12. Bid security of the 1st, 2nd & 3rd lowest Electronic bidders for the specific work will be retained by the department till the approval of bids.
- 13. Venue of bids opening IS OFFICE OF THE EXECUTIVE ENGINEER BUILDING DIVISION MOHMAND.
- 14. Financial bid shall be filled online complete bids must reach the concerned office on or before the fixed date /time.
- 15. The bidders are required to quote their rates above or below on both MRS as well as on non-MRS items.
- 16. Any Electronic bidders who provide incorrect/ incomplete information shall be non responsive.
- 17. Any Electronic bidders who submit fake or forged documents or information shall stand de-barred.
- 18. Electronic bids validity period is 90 days.
- 19. Successful bidder should sign the agreement with the department within Twenty Eight (28) days after issuance of LOA.
- 20. Call deposit of schedule Banks shall be acceptable.
- 21. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bidder declared through draw.
- 22. Technical bids will be opened after 30 minutes of closing time the presence of bidders / their representative who chows to be present.
- 23. The employer has authority to reject any bid or all the bids assigning cogent reasons.
- 24. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in Schedule-II of the Act ibid.
