1. The bidders are instructed to submit their bids through E-PAD System via <https://kp.eprocure.gov.pk>.
2. The bidder should submit their E-bids as per KPPRA Notification No.S.R.O(14)/Vol: 1-24/2021-22 dated: 10-05-2022.
3. Complete Detail of Bid Security in shape of CDR i.e Bank Name, CDR Number (s) and Date (s) must be submitted electronically along with E-bid on the E-Pak Acquisition & Disposal System (EPADS).
4. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority under the Khyber Pakhtunkhwa Finance Act, 2013 Act No.XXI of 2013.
5. Bid Security of 1st 2nd and 3rd lowest bidder will be retained by the procuring entity till approval of the bid.
6. Complete set of Bid solicitation documents/Criteria can also be obtained on submission of a written application alongwith Photo copies of KPRA, PEC, Enlistment C&W Department renewal for the Year 2025-26, upto **17/10/2025**, from the office of the undersigned on cash payment non refundable amounting to Rs.5000/, otherwise bids submitted without these documents will not be processed for post qualification.
7. All bidders shall submit an affidavit in the Technical bid, stating that bid security + Additional Security has been placed in the Financial bid without indicating figure, Otherwise the Technical proposal will be considered as non responsive.
8. Any bidder applying for more then one work shall submit separate technical brochure clearly mentioning the name of scheme against which the technical bid is submitted.
9. Both the technical and financial bids must be submitted through the E-PADS portal. In addition, hard copies of the bids must also be submitted to office of the Executive Engineer C&W Building Division Charsadda. Bidders failing to submit their bids through systems shall be declared non-responsive, and their bids shall not be considered for evaluation.
10. Registration with PEC duly renewed for current year 2025-26 with specialization code **CE-01 /CE-09 /CE-10 /EE-02 /EE-04 /EE-06/EE-11** and enlistment renewal of C&W Department (2025-26).
11. Bidders with history of blacklisting from any Government / Private Organization shall not be considered for qualification.
12. Bid shall accompanied with 0.03% of E/Cost as tender entry fee in shape of separate CDR which is non refundable.
13. Bid Security of 1st 2nd and 3rd lowest bidder will be retained by the procuring entity till approval of the bid.
14. Pre-Bid meeting will be held on **10 -10-2025 at 11:00 (A.M)**
