
Terms & Conditions

1. Bidding documents and instruction to bidders can be downloaded from the official EPADS website and C&W website (www.cwd.gkp.pk) as well as KPPRA website (www.kppra.gov.pk) before the submission time.
2. Bidders who submitted their financial bids without a valid Call Deposit will be debarred from participating in bidding process on any stage.
3. Bidders shall be required to submit an affidavit on stamp paper affirming that the CDR enclosed in the sealed financial bid is authentic and original.

4. Bid Security 2%+ Stamp Duty of the Estimated Cost in the Shape of Call Deposit (in Original) shall be kept sealed in the financial proposal shall in addition. Place in affidavit in the Technical proposal.
 - I. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security to the extent of 2% of Engineer Estimate only.
 - II. The contractors quoting their bids more than 10% below upto 20% below on Engineer's Estimate shall submit along with their bids 8% **Additional Security** on Engineer Estimate in addition to 2% bid Security.
 - III. In case the bidder quotes more than 20% below the Engineer Estimate shall submit with his bid an additional security on engineer Estimate cost equal to the differential amount of submitted bid and engineer estimate along with detail rate analysis.
 - IV. If the bid is not accompanied by the Additional Security then the bid shall be considered as nonresponsive and the 2nd lowest bidder and so on will be considered accordingly.
 - V. The Additional Security shall be released to the contractor in four installments that is 25% to be released upon completion of 25% of the project, 50% to be released upon completion of 50% of the project, 75% to be released upon completion of 75% of the project and the remaining amount to be released after completion of the project.
 - VI. The KPPRA Notification No.SRO(14)Vol:1-24/2021-22 Dated:10-05-2022 is applicable to this Tender which is available online and can be seen in the office of the undersigned at any working hours.
 - VII. All previous orders, instructions and regulations issued regarding additional security shall stand superseded.
5. Financial bid of only technically qualified bidders will be opened after approval from the competent authority.
6. Photocopy of CDR's of 2% E/Money or 0.03% Tender Entry Fee will not be acceptable and shall be strictly rejected.
7. If the bid rate /cost of two or more than two bid are same, the successful bid will be decided through Toss.
8. The competent authority reserves the right to reject any or all the tenders by assigning the cogent reason.
9. Bid will be valid for (90) days.
10. Call deposit of schedule Bank shall be acceptable.
11. Electronic Bids will be displayed by online E-Bidding through EPADS system after 30-Minutes of closing time in presence of bidders/their representative.
12. All relevant documents i.e. registration with current renewal of C&W/PEC/CNIC must be attached with Financial Bids.
13. All other terms & conditions can be seen on official website of the C&W Department or from the office of the under signed on any working day during duty hours.
14. Bid Security of 1st, 2nd & 3rd lowest bidder will be retained by the procuring entity till approval of the bid.
15. Any bidder who provides incorrect information shall be stand disqualified and will be debarred.
16. All Federal /Provincial duties/ Stamp duties/ Taxes will be recovered as per directions of the Government issued from time to time.
17. Electronic bidding will be done on "Above/Below" system on BOQ/Engineer's Estimate, based on MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.

18. All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in Schedule-II of the Act *ibid*.
19. Technical Bids (Scaled) in Separate Envelops addressed to Executive Engineer Highway Division Khyber should be submitted on 09-07-2025 before 12Hrs (PM)
20. Tender Form Fees (non-refundable) @ 0.03% on tender cost in shape of separate call deposit should be accompanied with bid submission.
21. Joint Venture (JV) not allowed.
22. Any condition/Instruction if missing will be deal as per KPPRA rules.
23. All others conditions are intact and can be seen in the office of the undersigned during working hours.
