Terms and Conditions.

1. Bidding Solicitation Documents along-with Bidding Criteria, and instruction to bidders can be downloaded from the EPADS website and C&W department website (www.cwd.gkp.pk) before the submission deadline. Incomplete bids or bids lacking requisite documents shall not be considered for technical evaluation.
2. Bidders must submit an affidavit on stamp paper, placed in the Technical Proposal, affirming that the CDR enclosed in the sealed Financial Bid is genuine and original. Non-submission of the affidavit shall render the bid non-responsive.
3. A copy of the Technical Proposal as well as Financial Securities in the required format is mandatory and to be uploaded on EPADS System.
4. All bidders are required to quote their bids on "Above/Below" system on BOQ/Engineer's estimate, based on MRS-2020. Only two digits after the decimal point shall be considered for evaluation purposes.
5. Electronic Bids will be displayed by online through EPADS system after 30-Minutes of closing time in presence of bidders/their representative.
6. Bid Security of 1st, 2nd & 3rd lowest bidder will be retained by the Procuring Entity until approval of the bid.
7. Any bidder providing false or incorrect information shall stand disqualified and may be debarred.
8. The Procuring Entity reserves the right to reject any or all the bids by assigning valid reason.
9. Bid will be valid for (90) days.
10. All other terms & conditions including KPPRA amended Rules can be seen on official website of the C&W, KPPRA or from the office of the undersigned on any working day during working hours.

11. All applicable Federal/Provincial taxes, duties, and stamp duties shall be deducted as per Government rules in force.
12. Joint Venture (JV) is permissible as detailed in the Bidding Documents
13. Separate Brochure / Technical Proposals and required documents for each work shall be submitted clearly mentioning the Scheme Name and ADP Number.
14. The participating contractor(s) must submit their updated FBR (Active Status), KPRA (Active Status), PEC License and C&W Enlistment copies along-with for the current financial year, for each work, on the day of opening of tender(s).
15. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA).
16. The Financial Bid will be opened after the approval of Technical Bids from the Competent Authority.
17. Period of Completion will be based on Work Order.
18. Any condition/Instructions, if missing, will be dealt in light of the KPPRA rules.
19. A complete set of criteria / bid documents should be obtained (Mandatory) by an interested eligible bidder on submission of written application from the office of the undersigned on any working days before closing date on 18-02-2026 i.e., payment of Rs.5000/- (Nonrefundable). Failure to do so will result in non-entertainment of the bid.
20. Pre-Bid meeting will be held on 12-02-2026 in the office of Executive Engineer Mega Projects (South-II) D.I.Khan.
