Terms and Conditions

- Bid documents including instruction to Bidders will uploaded on E-PADs and C&W website for bidder convenience but the same set of criteria/ bid documents in hard form should also be obtained by an interested eligible bidder on submission of written application from the office of the undersigned on any working day before closing date on 24-08-2026 i.e payment of Rs. 4000 (Nonrefundable).
- Bid Security @ 2% of the Estimated Cost in the shape of Call Deposit Receipt (CDR) from any Scheduled Bank shall be kept sealed in the Financial Proposal. The original Call Deposit (in original) and E-Stamp Paper of the current month shall be attached in the Technical Proposal. It is further added that the following documents duly attested by the Oath Commissioner shall also be enclosed in the Technical Proposal i.e List of Staff List of Machinery Non Black-Listing Certificate Litigation Certificate Undertaking Certificate.
- The contractors quoting their bids more than 10% below up to 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly no further evaluation will be carried out.
- Similarly, a contractor quoting bid more than 20% below shall submit his bid with an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detail rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detail rate analysis and /or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive, the 2nd lowest bidder and so on will be considered accordingly. In case detail rate analysis submitted with the bids is in view of the procuring Entity, non-convincing, the Head of the Procuring Entity will declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- If a bidder fails to submit the original Bid Security (CDR) and Additional Security (CDR) as per instructions before the specified date and time, the procuring entity shall debar the bidder for a period of one (01) year. If the bidder commits the same violation a second time, the bidder shall be blacklisted for a minimum period of three (03) years.
- A copy of Technical Proposal in the required format is mandatory and to be uploaded as a part of E-PADs.
- All taxes should be deducted as per government rules and policy.
- Scanned copy of bid security shall be submitted electronically along with Technical bid on E-PADs system. Bids must be accompanied by a non-refundable Tender Fee @ 0.03% of the Engineer's Estimate; in the shape of CDR otherwise bidder will be considered disqualified.
- All the bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority, Established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works consulting and non-consulting service as listed in schedule-II of Act ibid..
- The bidders should submit their Technical/Financial Bid on E-PADs as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22: Dated 10/05/2022.
- Technical bids (sealed) in separate envelopes may be addressed to Executive Engineer Maintenance-II Division should be submitted till closing date in addition to upload on E-PADs. (optional)
- If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw.
- Bids submitted by bidders who have pending tender fee dues in past tenders their bid will be rejected straight away.
- Opening of Technical Bid, Office of Executive Engineer Maintenance-II Division, at Bacha Khan Chowk Peshawar.
- Details evaluation criteria should be obtained from the undersigned office on any working day before last date of submission.
