(KPPRA Single stage two envelop bidding procedure)

- Original Copies of Call Deposit for Bid security should be enclosed in the Technical Proposal and shall reach to the Office before closing date/time.
- Submission of forged or misleading documents (if found at any stage) will result in disqualification. Additionally, punitive actions—including legal and financial penalties—may be imposed.
- All the prevailing rules of the KPPRA shall be applicable.
- For detail terms and conditions refer to the Bid Solicitation Documents (BSD).
- Bid not fulfilling any of the criteria as stated above and in the bidding documents will be declared non-responsive.
- The Financial Bid will be opened after the Approval of Technical Bids from the Competent Authority.
