- Bidding Solicitation Documents along-with Bidding Criteria and instruction to bidders can be downloaded from the official EPADS website and C&W website (www.cwd.gkp.pk) as well as KPPRA website (www.kppra.gov.pk) before the submission time. Bids submitted without requisite documents or incomplete will not be processed further for Technical Evaluation.
- Bidders must submit an affidavit on stamp paper with the Technical Proposal confirming that the CDR in the sealed financial bid is original and authentic; otherwise the bid will be considered non-responsive.
- All the bidders will have to submit CDR from scheduled Bank on Account of bidding entry fee (Not refundable) for each bid @0.03% of the estimated cost without fail, otherwise his bid will not be entertained.
- Original CDR for Bid Security (from a Scheduled Bank), Stamp Duty, and Bid Entry Fee @0.03% of the estimate cost must be submitted with the Technical Proposal before the closing date/time.
- A copy of the Technical Proposal as well as Financial Securities in the required format is mandatory and to be uploaded on EPADS System.
- Electronic bidding will be done on "ABOVE/BELOW/ATPAR" system on BOQ/ Engineer's Estimate, based on MRS applicable. Only two digits after the decimal point shall be considered for evaluation purposes.
- Electronic Bids will be displayed by online E-Bidding through EPADS system after 30-Minutes of closing time in presence of bidders/their representative.
- Bid Security of 1st, 2nd & 3rd lowest bidder will be retained by the Procuring Entity till approval of the bid.
- Any bidder who provides incorrect information shall stand disqualified and will be debarred.
- The competent Authority reserves the right to reject any or all the tenders by assigning the cogent reason(s).
- Bid will be valid for (90) days.
- Details of similar nature and other general works, in hand and completed during last five years supported by work orders and completion certificates duly attested from Executing Agencies concerned.
- Machinery (Tools, Plants & Equipment etc.) supported with the purchase documents as evidence of ownership.
- Details of technical staff/engineers with updated CVs, qualifications, and agreement with the firm on stamp paper (for the current year) must be provided, along with an affidavit confirming their availability for the project including PEC registration numbers and contact details. Financial soundness supported by annual Audit reports for the current year.
- Tax returned certificate for the current year.
- All other terms and conditions, including KPPRA amended rules, can be obtained from the C&W Department website or the office of the undersigned during working hours.
- All Federal / Provincial duties / Stamp duties / Taxes will be recovered as per direction of the Government issue from time to time.
- Joint Venture (JV) is allowed as per C&W Rules and Regulations / KPPRA Rules.
- The Participating contractors(s) must submit their updated FBR (Active Status), KPRA (Active Status), PEC Licenses and C&W Enlistment copies for the current financial year, on the day of opening of tender(s).
- All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) under Finance Act 2013 Act No. XXI of 2013.
- The Financial Bid will be opened after the approval of Technical Bids from the Competent Authority.
- Period of Completion will be based on Work Order(s).
- Any condition/Instructions, if missing will be dealt in light of KPPRA rules.
- Contractors whose past performance is not satisfactory with this Division shall be considered non-responsive.
- Pre-Bid meeting will be held on 31.03.2026 in the office of C&W Building Division-II Peshawar at 11:00 AM.
