1. Bid Solicitation Documents and Instructions to Bidders can be obtained from the office on any working day or downloaded from C&W website (www.cwd.gkp.pk) before the submission date/time.
2. The bidders should submit their E-bids as per KPPRA Notification No. SOR (14)/Vol: 1-24/2021-22 dated 10.05.2022 being amended till now and submission of performance security in accordance with SBDs notified by Government of Khyber Pakhtunkhwa.
3. Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically along with E-bid on the E-Pads System.
4. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority under Finance Act, 2013 Act No. XXI of 2013.
5. The bidding entry Fee/Tender Form Fee shall be annexed in shape of separate CDR of estimated Cost which will be non-refundable.
6. Venue of Bids opening is office of the Executive Engineer C&W Division No.II Buner.

**INSTRUCTION TO BIDDERS
(Single Stage Single Envelop E-Pak Acquisition & Disposal System).**

1. The bidders are required to quote their rates above or below on both MRS as well as on non MRS items.
2. I) The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @2% only of Engineer estimate.
ii) The contractors quoting their bids more than 10% below up to 20% below on Engineer estimate shall submit along with their bids 8% Additional Security of Engineer estimated cost in addition to 2% bid security if the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid and 2% bid security shall be forfeited in favour of Govt: and the 2nd lowest bidder and so on will be considered accordingly.
iii) Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer Estimate cost equal to the differential amount of submitted bid and Engineer Estimate along with detailed rate analysis). In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and/or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non responsive bid shall be forfeited in favour of government and the 2nd lowest bidder so on will be considered accordingly.
iv) In case of detail rate analysis submitted with the bids is, in view of the procuring Entity, not convincing, the head of the procuring Entity may declare such bid as non responsive with any forfeiture of the bid securities and record reasons thereof.
v) The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
vi) After commencement of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank: if the already deposited security is not in the form of bank guarantee.
vii) The Additional Security shall be released to the contractor in four installments i.e., 25% to be released upon completion of 25% of the project. 50% to be released upon completion of 50% of the project. 75% to be released upon completion of 75% of the project and the remaining amount to be released after completion of the project.
viii) All previous orders, instructions and regulations issued regarding additional security shall stand superseded.
3. All such effort to conspire to cartel making shall be considered as violation of Rule-44 and shall be attributed towards mis-procurement under Rule-54 of procurement Rules ibid.
4. Electronic Bids should be submitted electronically on or before the fixed date/time.
5. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
6. Time allowed for completion of the work is as specified in the NIT which will start from the issuance of LOA.
7. Electronic Bids will valid for Ninety (90) days.
8. Successful Bidder should sign the agreement with the department within Twenty-Eight (28) days after acceptance of bid.
9. Call Deposit of Scheduled Banks shall be acceptable.
10. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bidder will be declared through draw.
11. Electronic Bids will be displayed by Online E-PADS System after 30 minutes of closing time in the presence of bidders/their representatives who choose to be present.
12. The employer has the authority to reject any E-Pads Bids or all the E- Pads bids assigning valid reason.
13. Bid Security of 1st, 2nd and 3rd lowest bidders will be retained by the employer till approval of bid.
