

2. The bidders should submit their E-bids as per KPPRA Notification No. SOR (14)/Vol: 1-24/2021-22 dated 10.05.2022.
3. Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically along with E-bid on the E-Pads System.
4. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority under Finance Act, 2013 Act No. XXI of 2013.
5. Venue of Bids opening is office of the Executive Engineer C&W Division No.1 Buner.
6. The bidding entry Fee/Tender Form Fee shall be annexed in shape of separate CDR of estimated Cost which will be non-refundable.
7. No bid will be opened in the absence of original bidder or their authorized representative.
8. No bid received by hand will be accepted except received through courier services.
9. No government officer/official is allowed to submit any bid of the contractor, action will be recommended against him to higher-ups.

GENERAL TERMS AND CONDITIONS

1. Bid Solicitation Documents and Instructions to Bidders can be obtained from the office on any working day or downloaded from Forest Division Buner website www.cwd.gkp.pk before the submission date/time.
2. The bidders should submit their E-bids as per KPPRA Notification No. SOR (14)/Vol:1-24/2021-22 dated 10.05.2022.
3. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required of additional security, then the said bid will be dealt as per KPPRA Notification S.R. O (14) / Vol: I 24/2021-22 dated 10-05-2022.
4. In case detailed rate analysis submitted with the bids is, in view of the procuring Entity not convincing, the head of procuring Entity may declare such bid as non-responsive.
5. Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically along with E-bid on the E-PADS System.
6. In cases of equal bids amongst the successful bidder, winner will be decided based on toss in the presence of all the bidders.
7. Bid not fulfilling any of the criteria as stated above and in the bidding documents will be declared non-responsive.
8. All federal / Provinces/stamp duties/Taxes will be recovered as per directions of the Government issued from time to time
9. Electronic bids will be displayed by online EPAD system after 30-Minutes of closing time in presence of bidders/ their representative.
10. Photo copy of CDR's of 2% E/Money & 0.03% Tender Entry fee will not be acceptable and shall be strictly rejected.
11. The Competent authority reserves the right to reject any or all the tenders by assigning the cogent reason.
12. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
13. Venue of bids opening is the office of the Executive Engineer C&W Division-I Buner.
14. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013, for the works, consulting and non-consulting services as listed in Schedule-II of the Act ibid"
15. The bidding entry Fee/Tender Form Fee shall be annexed in shape of separate CDR of estimated Cost which will be non-refundable
16. All contractors/ firms are required to strictly follow the KPPRA circular No. S.R.O. (35) /Vol: 1-46/2025-26 dated: 27-08-2025.
17. All CDRs received will be processed though treasury.
18. CDRs of contractor 2nd and 3rd and subsequent will be released after approval of the tender by the competent authority.
