**NOTICE INVITING E-BIDDING**

**Single Stage Single Envelop E-Pak Acquisition and Disposal System (E-PADS)**

The C & W Division Shangla Government of Khyber Pakhtunkhwa invites Electronic Bids from eligible firms /contractors in accordance with KPPRA procurement Rules, amended up to 29-10-2025 on Single Stage Single Envelope Procedure for the following works: -

**INSTRUCTION TO BIDDERS**

- The contractor quoting their bids up to a limit of 10% below on Engineer Estimate shall submit bid security @ 2% only of Engineer Estimate.
- The contractor quoting their bids more than 10% below up to 20% below on Engineer Estimate shall submit along with their bids 8% Additional Security of Engineer Estimate cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
- Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer Estimated cost equal to the differential amount of submitted bid and Engineer Estimate along with detail rate analysis which should be uploaded on E-Pads (Mandatory). In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis on E-Pads and/ or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
- In case detailed rate analysis submitted with the bids is, in view of the procuring Entity, not convincing, The Head of the procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurements opportunity afresh.
- The additional Security submitted by the bidder at the time of bidding should be inn the shape of call deposit of the schedule Banks. No additional security presented in the shape of Bank Guarantee will be acceptable at the stage of bid opening.
- The additional security shall be released to the contractor in four installments i.e 1st installments of 25% to be released upon completion of 25% of the project, 2<sup>nd</sup> installments of 25% to be released upon completion of 50 of the project, 3<sup>rd</sup> installment of 25% to be released upon

- completion of 75% of the project and the 4<sup>th</sup> installment of 25% to be released after 100% completion of the project.
8. All bidders shall enter the details of the bid security and, where applicable, the additional security instrument in the E-PAK Acquisition and Disposal System (EPADS) at the time of bid submission. The original bid security and additional security instruments, details of which have already been entered in EPADS, shall be submitted to the procuring entity well before the closing date and time of bid submission. The procuring entity shall retain the original bid security and additional security instruments of all bidders until signing of the contract with the best evaluated bidder or till the bid validity period whichever is earlier
    - i. In case of failure to submit the original bid security and additional security instrument before the date and time, the procuring entity shall debar the bidder for a period of one (01) year.
    - ii. In the case of violation for second time, blacklist him for a minimum period of three (03) years in accordance with Section 29 of the KPPRA Act read with Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014.
  9. All previous orders, instruction and regulations issued regarding additional security shall stand superseded.
  10. All such effort to conspire to cartel making shall be considered as violation of Rule-44 and shall be attributed towards mis-procurement under Rules-54 of procurement Rules.
  11. Electronic bids should be submitted electronically before the fixed date/time as per KPPRA notification No.S.R.O(14)Vol1-24/2021-22/6058-71 Dated 05/10/2022.
  12. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
  13. Time allowed for completion of work is as specified in the NIT which will start from the Issuance of LOA.
  14. Electronic bids will be valid for Ninety (90) days.
  15. Successful bidder should sign the agreement with the department within 28 Days after acceptance of Bid and issuance of LOA
  16. Call deposit of scheduled banks shall be acceptable and pay orders are not acceptable.
  17. If the evaluated electronic bid cost of two or more than two bidders are equal then the successful bidder will be declared through draw.
  18. Electronic bids will be displayed by online E-Bidding system after 30-minutes of closing time in presence of bidders/their representatives who choose to be present.
  19. The employer has the authority to reject any E-bid or all the E-bids assigning valid reason.
  20. Bid security of all bidders will be retained by the employer till approval of bid.
  21. All bidders are required to be registered with KPPRA Revenue Authority established under Finance Act,2013 Act No.XXI of 2013.
