
## TENDER NOTICE

Communication & Works Department, C&W Division South Waziristan Lower at Wana invites tender through EPADS System from the eligible Firms/Bidders enlisted with C&W Department and Pakistan Engineering Council having valid renewal for Financial Year 2024-25, 2025-26, in accordance with KPPRA Procurement Rule-2014, on Single Stage Single Envelope procedure on EPADS for the following works:-

- Bidding documents and instruction to bidders can be downloaded from C&W website ([www.cwd.gkp.pk](http://www.cwd.gkp.pk)) as well as KPPRA website ([www.kppra.gov.pk](http://www.kppra.gov.pk)) before the submission time.
- The Bid Security shall be 2% of the engineer estimate (Stamp Duty must be added) in shape of Call Deposit in the name of "Executive Engineer C&W Division South Waziristan Lower".
- The contractors quoting their bid more than 10% below upto 20% below on Engineer's Estimate shall submit along with their Bids 8% Additional Security of Engineer Estimate cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly vide KPPRA Notification No.S.R.O(14)/Vol:1-24/2021-22 dated 10.05.2022.
- (Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineer's Estimate along-with details rate analysis). In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and/or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along-with such non-responsive bid shall be forfeited in favour of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
- All the bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services a listed in Schedule-II of the Act ibid.
- If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will be declared through draw.
- All the bidders are required to deposit the bidding entry fee Rs: 0.03% on Tender Cost by each participating contractor online along-with earnest money which will be non-refundable vide C&W Secretariat letter No.SO(B)/1-102/CMD/CS/PBC/2020-21/C&WD dated 12.04.2021.
- The undersigned has the authority to reject any Bid or all the Bids assigning valid reason.
- Venue of bids submission and opening is office of the Executive Engineer C&W Division South Waziristan Lower at Wana, (Office of the Executive Engineer C&W Division South Waziristan Lower has been shifted from District Tank to Wana vide Secretary C&W Department Office Order No. SOE/C&WD/13-01/2025 dated 18.04.2025).
