- Technical Bid of interested bidders should accompany the following mandatory documents
  - Active registration with Pakistan Engineering Council in the relevant category.
  - Enlistment Order of C&W Department (photocopy)
  - Renewal of registration for CFY 2025-26 (Photocopy)
  - National Identity Card (CNIC Photocopy)
  - Active status with FBR.
  - Registration with KPRA.
  - Form H of the Company/ Firm.
  - An affidavit with undertaking in the technical bid that Bid Security and additional security (if any), in original, have been enclosed in the financial bid.
  - An affidavit with undertaking of No involvement in litigation with the procuring entity.
  - Any other document to support the technical bid and required in the bid solicitation document.
- All bids must be accompanied by tender form fee @ 0.03% , Bid Security @ 2% of the engineer's estimate along with Additional security, if applicable as per KPPRA S.R.O. (14)/Vol: 1-24/2021-22 , in original in the name of Executive Engineer Lower C&W Division Kurram.
- Completed details of bid and additional securities along with their scanned copies must be submitted electronically with the technical bid on the EPAD's system.
- Incomplete bids, unsealed bids or those received after the closing time, will not be entertained. Authorized representatives who submit bids within the stipulated time must sign the bidder's attendance sheet.
- Bidders must quote their rates electronically as "ABOVE/BELOW/AT PAR" for the priced BOQ/Engineer's Estimate based on the MRS applicable. Only two digits after the decimal points will be considered for evaluation purpose.
- The bidding process will be carried out as per KPPRA S.R.O. (14)/Vol: 1-24/2021-22.
- In case the detailed rate analysis submitted with the bids are not found convincing in view of the procuring entity, the procuring entity may reject the bid without forfeiture of bid security and record reasons thereof.
- Successful bidder must sign the contract agreement with the department within the stipulated time.
- Any bidder who provided incorrect or misleading information shall stand disqualified as per KPPRA Act Section 29(I) rule (43).
- Bids will be valid for a period of ninety (90) days.
- Joint Venture (JV) is not allowed.
- Incase evaluated bids of two or more than two bidders are the same then the successful bid will be declared through open draw/toss.
- Any condition/instruction not specified herein shall be governed by the prevailing rules of KPPRA, as issued and amended from time to time, and shall be observed during the procurement process.
- The competent authority reserves the right to reject any or all the bids assigning cogent reasons.
