- ii. The participating contractor(s) must submit their updated FBR (Active Status), KPPRA (Active Status), PEC License and C&W Enlisted copies for the current financial year, for each work, on the day of opening of tenders.
- iii. Complete detail of Bid Security in shape of CDR i.e. Bank name, CDR Number(s) and Date(s) must be submitted electronically along with E-Bid on the E-PAD System.
- iv. Bid must be accompanied by a non-refundable Tender Fee@ 0.03% of the Engineer's Estimate in the shape of CDR, as per instruction issued by Section Officer (Confidential) Chief Minister Secretariat vide letter No. SO@CMS/KPK/2021/2828/35/W/E Dated 05-04-2021.
- v. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority under Finance Act, 2013 Act No. XXI of 2013.
- vi. Venue of Bids opening is office of the Executive Engineer C&W Building Division Mardan Opposite Near CMH Mardan.
- vii. The undersigned has the right to reject the Bid of those Contractors whose past performance is not satisfactory with this Division and shall be considered as non-responsive.
- ix. Bidding process will be held as per KPPRA Notification vide . S.R.O (14)Vol: 1-24/2021-22/6058-71 dated 10/05/2022.
- x. In case detailed rate analysis submitted with the bids is, in view of the of the procuring Entity, not convincing, the Head of Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- xi. As per KPPRA, vide letter No. KPPRA/MIS/EPADS/24-25/266 dated 16/04/2025 the Tender will be process on KPPRA website through E-PADS System.

INSTRUCTION TO BIDDER (ITB)

1. The bidder shall submit through courier 2% bid security sealed envelope of the Engineer Estimated cost in the shape of Call Deposit in (original) along with photo copies before closing date and time.
2. The bidders should submit their E-bids as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22: Dated 10/05/2022.
3. Copies of valid registration with PEC, FBR and KPRA-Active Tax Payer.
4. Copy of valid Enlistment Certificate of C&WD for the Current Year.
5. National Identity Card (CNIC photocopy).
6. Form H in case of Company/ Firm.
7. Financial soundness supported by annual audit reports for the current year.
8. Tax Return Certificate for the current year.
9. The bidders are required to quote their rates (electronically) *ABOVE/BELOW/AT PAR" for both priced BOQ/Engineer Estimate based on MRS and NSI as well. Only two digits after the decimal point shall be considered for evaluation purpose.
10. The successful bidder shall be subjected to all admissible taxes including Stamp duty, service charges, sales tax and any other at prevailing rate.
11. Financial Bid shall be filled online. Complete bid must reach this office on or before the fix date and time.
12. Time allowed for the completion of the work as specified in the NIT shall start from the issuance of work order.
13. Electronic Bid validity period is 90-days.
14. Successful Bidders should sign the Agreement with C&WD within (28) days after issuance of letter acceptance.
15. Call deposit and Bank guarantee of scheduled banks shall be acceptable.
16. If the evaluated electronic bid cost of two or more than two bidders are equal than the successful bid will be declared through open draw.
17. Financial Bids will be opened in office of the Executive Engineer C&W Building Division Mardan after 30 minutes of closing time in the presence of bidders/their representative who choose to be present.
18. The procuring entity has the authority to reject any bidder all the bids assigning cogent reason.
19. Bid security of the first, second and third lowest bidders for the specific work will be retained by the Authority till the approval of bids.
20. All the information in documents provided by the bidders must be based on facts beyond any doubt. Any misrepresentation, false statement or fake document found in the proposal at any stage, would lead to debarment/blacklisting of the firm. The matter may also be reported to the PEC for cancellation of registration/license of the respective firm.
21. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in Schedule-II of the Act ibid.
