

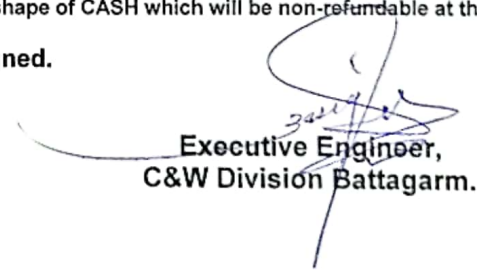
NOTICE INVITING BIDS THROUGH E-PADS

C & W Department (Division, District Battagram), Government of Khyber Pakhtunkhwa invites electronic Bids through E-PADS from eligible firms /contractors in accordance with KPPRA procurement Rules 2014 on single stage single envelop procedure for the following works.

2. The Participating contractor(s) must submit their updated FBR (Active Status), KPPRA (Active Status), PEC License and C&W Enlistment Copies for the Current financial year.
3. Complete details of Bid Security in shape of CDR i.e. Bank Name, CDR Number (s) and date(s) must be submitted electronically on E-PADS System.
4. All bidders are required to be register with Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act ibid".
5. Bidding Process will be held as per Khyber Pakhtunkhwa Public Procurement Regulatory Authority Notification No.S.R.O.(14)/Vol:1-24/2021-22/6058-71 dated 10-5-2022 which is available in the KPPRA web site.
6. As per C&W Secretariat Notification No.SO(B)I-102/CMD/PBC/2020-21/C&WD dated 12-04-2021 the bidding entry fee @0.03% of the tender cost must be attached in shape of CASH which will be non-refundable at the time of bid submission.
7. Venue of Bids opening is office of the undersigned.

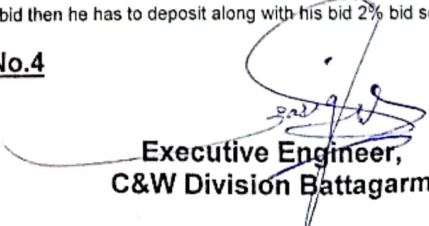

INSTRUCTIONS TO BIDDERS.
NOTICE INVITING BIDS THROUGH E-PADS
(SINGLE STAGE SINGLE ENVELOP E-PADS)**

1. The bidder shall submit 2% Bid Security of the Estimated Cost in the shape of deposit at call (original) before half an hour before closing date and time.
2. As per Govt:of Khyber Pakhtunkhwa Public Procurement Regulatory Authority Notification No. S.R.O.(14)/Vol:1-24/2021-22/6058-71 dated 10-5-2022 which is available in the KPPRA web site.
i.e. In exercise of the powers conferred under Section 35-A of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority Act, 2012 (Khyber Pakhtunkhwa Act No. XI of 2012) the Authority has been pleased to issue the following regulation, namely: -
 1. **Short title and commencement.-** (i) This regulation may be called the Khyber Pakhtunkhwa Public Procurement Regulation No. XIV 2022.
(ii) This shall come into force at once.
 2. **Matters pertaining to Additional Security in case of abnormally low bids.-** This regulation relates to the matters pertaining to Additional Security submitted by the bidders in procurement of works.
 - i. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineer Estimate.
 - ii. The contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
 - iii. [Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis]¹. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.

¹ Differential amount; if a contractor quote, e.g. 25% below engineer estimate bid then he has to deposit along with his bid 2% bid security and 25% additional security of engineer estimate.

- iv. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
 - v. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
 - vi. After commencements of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank; if the already deposited security is not in the form of bank guarantee.
 - vii. The Additional Security shall be released to the contractor in four installments i.e. 1st installment of 25% to be released upon completion of 25% of the project, 2nd installment of 25% to be released upon completion of 50% of the project, 3rd installment of 25% to be released upon completion of 75% of the project and the 4th installment of 25% to be released after 100% completion of the project.
 - viii. All previous orders, instructions and regulations issued regarding additional security shall stand superseded.
3. Electronic Bids should be submitted electronically on or before the fixed date/time.
 4. Electronic Bidding shall be done on "Above/Below" system on BOQ/Engineer's estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
 5. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
 6. Time allowed for completion of the work is as specified in the NIT which will start from the issuance of LOA.
 7. Electronic E-PADS Bids will valid for Ninety (90) days.
 8. Successful Bidder should sign the agreement with the department within Twenty-Eight (28) days after acceptance of bid.
 9. Call Deposit of Scheduled Banks shall be acceptable.
 10. If the evaluated electronic bid costs of two or more than two bidders are equal, then the successful bidder will be declared through draw.
 11. Electronic E-PADS Bids will be displayed by Online E-PADS Bidding System after 30 minutes of closing time in the presence of bidders/ their representatives who chose to be present.
 12. The employer has the authority to reject any E-PADS bid or all the E-PADS bids assigning valid reason.
 13. Bid security of 1st, 2nd and 3rd lowest bidders will be retained by the employer till approval of bid.
 14. Pay order shall not be accepted as per KPPRA Notification No.KPPRA/M&E/Estt/1-12/2017-2018 dated 05-04-2018. (The above instruction to bidders has been revised in light of the KPPRA Rules 2014. The same was discussed with the Secretary to Govt: of KPK C&W Department Peshawar and approved for circulation to the field office for immediate implementation vide Chief Engineer(North) C&W Department Peshawar No.1120/1-T dated 05-11-2018).
 15. AS PER MINUTES OF THE MEETING REGARDING STANDARD N.I.T. UNDER THE CHAIRMAN SHIP OF SECRETARY C&W DEPARTMENT ON 3-8-2018 VIDE DIRECOR P&M C&W DEPARTMENT No. D(P&M)/C&WD/1043/2018 DATED 17-8-2018 RECEIVED IN THIS OFFICE VIDE SUPERINTENDING ENGINEER(HQ)OFFICE OF THE CHIEF ENGINEER (EAST) C&W DEPARTMENT ABBOTTABAD NO.1840/2-M DATED 17-9-2018, THE FOLLOWING CONDITION WILL BE ADDED IN THE STANDARD NIT;-
 - (a) "Bidders who submit their financial bids without a valid C.D. will be debarred from Participating in bidding process for one year.
 - (b) The bidder should be enlisted with the Khyber Pakhtunkhwa Revenue Authority, as per KPPRA rules.
 16. As per C&W Secretariat Notification No.SO(B)I-102/CMD/PBC/2020-21/C&WD dated 12-04-2021 the bidding entry fee @0.03% of the tender cost must be attached in shape of CASH which will be non-refundable at the time of bid submission.
