4. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) under Finance Act, 2013 Act No. XXI of 2013.
5. As per KPPRA Notification No. SRO(14)/Vol:1-24/2021-22/6058-71 dated 10th May, 2022 regarding Bid Security & Additional Bid Security clear instructions have been given in the said Notification of KPPRA and the clauses shall be implemented on this bid.
