

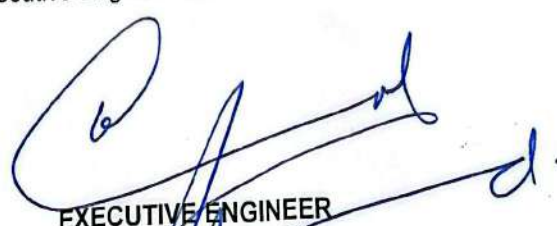

C&W Department (C&W Building Division District Orakzai) Government of Khyber Pakhtunkhwa invites electronic Bids from the eligible firms/bidders in accordance with KPPRA Procurement rules 2014 on single stage single envelope procedure for the following works.

- Bid Solicitation Documents and instructions to Bidder can be obtained from the office on any working day or downloaded from (www.cwd.gkp.pk) before the submission date/time.
- As per KPPRA notification No. SRO.(14)Vol:1-24/2021-22 dated 10/05/2022/6058-71 security shall be submitted by the bidders as under:
 - The Contractor quoting their bid more than 10% below on Engineer Estimate shall submit bid security to the extend of 2% of Engineer Estimate only.
 - The Contractor quoting their bid more than 10% below upto 20% below on Engineer Estimate shall submit alongwith their bid 8% **Additional Security** of Engineer Estimate cost in addition to 2% bid security if the bid is not accompanied with required amount of additional security then it will be considered as non-responsive and the 2% bid security be forfeited in favour of government and the second lowest bidder and so on will be considered accordingly.
 - Similarly a contractor quoting bid more than 20% below shall submit with this bid an additional security on Engineer Estimate cost equal to the different amount of submitted bid and Engineer Estimate alongwith detail rate analysis. In case of more than 20% below bids if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security then the said bid shall be considered as non-responsive. All the securities submitted alongwith such non-responsive bid shall be forfeited in favour of government and the second lowest bidder and so on will be considered accordingly.
 - In case detailed rate analysis submitted with the bids is in view of the procuring entity not convincing. The head of the procuring entity may declare such bid as non-responsive without any forfeiture of bid securities and record reason thereof.
 - The procuring entity may offer the contract to next lowest bidders after due diligence in the context of financial difference below such two bids or may advertise procurement opportunity afresh.
- Submission of forged or misleading documents (if found at any stage) will result in disqualification additionally. Punitive action including legal and financial penalties may be imposed.
- All the prevailing rules of the KPPRA shall be applicable.
- Bid not fulfilling any of the criteria as stated above and in the bidding documents will be declared non responsive.
- The Competent Authority reserves the right to reject any OR all bids by assigning cogent reasons
- Bid shall accompanied with 0.03% of E/Cost as tender entry fee in shape of separate CDR Which is non-refundable.
- The venue to the Bid opening is the office of the Executive Engineer C&W Division Orakzai.
