

5. Submission of forged or misleading documents (if found at any stage) will result in disqualification. Additionally, punitive actions—including legal and financial penalties—may be imposed.
6. All the prevailing rules of the KPPRA shall be applicable.
7. For detail terms and conditions refer to the Bid Solicitation Documents (BSD).
8. Bid not fulfilling any of the criteria as stated above and in the bidding documents will be declared non-responsive.
9. The Financial Bid will be opened after the Approval of Technical Bids from the Competent Authority.
