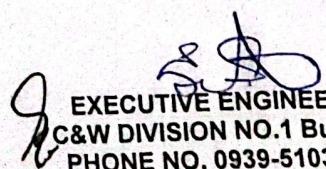

MANDATORY DOCUMENTS TO BE SUBMITTED WITH THE BID

1. Proof of registration with Pakistan Engineering Council (PEC) in C6 Category, duly renewed for the current year. (2) Proof of registration with Khyber Pakhtunkhwa revenue Authority (Active Tax payer list) under Finance Act, 2013 Act No. XXI of 2013. (3) Photo copy of CNIC. (4) Affidavits on declaration of no default/blacklisted or involved in litigation with the department. (5) Complete bidding documents-duly signed.

GENERAL TERMS AND CONDITIONS

1. Bid Solicitation Documents and Instructions to Bidders can be obtained from the office on any working day or downloaded from C&W website www.cwd.gkp.pk, and KPPRA websites www.kppra.gov.pk before the submission date/time.
2. The bidders should submit their E-bids as per KPPRA Notification No. SOR (14)/Vol:1-24/2021-22 dated 10.05.2022.
3. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required of additional security, then the said bid will be dealt as per KPPRA Notification S.R. O (14) / Vol: I 24/2021-22 dated may 10-2022.
4. In case detailed rate analysis submitted with the bids is, in view of the procuring Entity not convincing, the head of procuring Entity may declare such bid as non-responsive.
5. Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically along with E-bid on the E-PADS System.
6. If the evaluated electronic bid costs of two or more than two bidders are equal then the successful bid will declare through open draw.
7. Bid not fulfilling any of the criteria as stated above and in the bidding documents will be declared non-responsive.
8. All federal / Provinces/stamp duties/Taxes will be recovered as per directions of the Government issued from time to time
9. Time allowed for the completion of the work will be specified in Work Order and shall start from the issuance of Work Order.
10. Electronic bids will be displayed by online E-Bidding system after 30-Minutes of closing time in presence of bidders/ their representative.
11. The bidders are required to quote their rates on E-Bidding System "ABOVE / BELOW / AT PAR" for Schedule & Non-Scheduled Items based on MRS 2025 (1st Annual). Only two digits after the decimal point shall be considered for evaluation purpose.
12. Photocopy of CDR's of 2% E/Money of 0.03% Tender Entry fee will not be acceptable and shall be strictly rejected.
13. The Competent authority reserves the right to reject any of all the tenders by assigning the cogent reason.
14. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
15. Venue of bids opening is the office of the Executive Engineer C&W Division-I Buner.
16. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013, for the works, consulting and non-consulting services as listed in Schedule-II of the Act ibid"
17. The bid securities of unsuccessful bidders will be returned upon award of contract to the successful bidder or on the expiry of validity of Bid Security whichever is earlier
18. The bidding Entry Fee/Tender Form Fee shall be annexed in shape of separate CDR of estimated Cost which will be non-refundable.
19. All contractors/ firms are required to strictly follow the KPPRA circular No. S.R.O. (35) /Vol: 1-46/2025-26 dated: 27-08-2025.
