



4. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013, for the works, consulting and non-consulting services as listed in Schedule-II of the Act ibid".

It is pertinent to mention that as per section 2(1) (n) of KPPRA Act, 2012 read in conjunction with rules 54, public procurement in contravention to the provisions of this act or any other laws in respect of or relating to public procurement including any rules regulations orders or instructions made in this behalf shall constitute mis procurement and person responsible for such breach shall liable to be proceeded under the relevant law.
